18	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:	
19		
20	SECTION 1. (a) There is created the "Taskforce to Study the Revision	<u>n</u>
21	of Property Tax Law".	
22	(b) The taskforce shall be composed of the following members:	
23	(1) Two (2) members appointed by the Speaker of the House of	
24	Representatives as follows:	
25	(A) One (1) member shall be a citizen of the State of	
26	Arkansas; and	
27	(B) One (1) member selected from a list of no fewer than	
28	five (5) names submitted by the Arkansas Education Association;	
29 30	(2) Two (2) members appointed by the President Pro Tempore of the Senate as follows:	
31	(A) One (1) member shall be a citizen of the State of	
32	Arkansas; and	
33	(B) One (1) member selected from a list of no fewer than	
34	five (5) names submitted by the Arkansas Association of Educational	
35	Administrators;	
36	(3) One (1) member appointed by the Governor;	



1	(4) The Director of the Assessment Coordination Department, or
2	his or her designee;
3	(5) The Administrator of the Office of Motor Vehicle of the
4	Revenue Division of the Department of Finance and Administration or his or
5	her designee;
6	(6) Two (2) members appointed by the Arkansas Association of
7	Counties;
8	(7) One (1) member appointed by the Arkansas Municipal League;
9	<u>and</u>
10	(8) The Commissioner of State Lands or his or her designee.
11	(c) The terms of the members of the taskforce shall expire on December
12	<u>31, 2004.</u>
13	(d) Vacancies on the taskforce shall be filled in the same manner as
14	provided for in the initial appointment.
15	(e) The chairperson shall be selected by the members of the taskforce.
16	(f)(1) The taskforce shall meet no less than monthly at dates to be
17	determined by the chairperson.
18	(2) The chairperson shall call the first meeting, which shall be
19	held no later than thirty (30) days after the effective date of this act.
20	(g) The members of the taskforce shall serve without compensation and
21	shall not receive per diem, mileage, or stipends.
22	(h) The taskforce shall receive staff support from the Bureau of
23	Legislative Research.
24	
25	SECTION 2. (a) The purpose of the Taskforce to Study the Revision of
26	Property Tax Law is to study the feasibility of the same-year assessment and
27	collection of property tax.
28	(b) The taskforce shall:
29	(1) Examine the statutory changes necessary to implement same-
30	year assessment and collection of property tax;
31	(2) Propose legislation for the 2005 Regular Session of the
32	General Assembly consistent with its examination of current state law;
33	(3) Examine whether constitutional changes are required to
34	implement same-year assessment and collection of property tax;
35	(4) If constitutional changes are required, to propose a joint
36	resolution for a constitutional amendment for the 2005 Regular Session of the

1	General Assembly consistent with its examination of the constitutional law;
2	(5) To assess the benefits and costs of implementing same-year
3	assessment and collection of property tax; and
4	(6) To make other recommendations for improving the efficiency
5	of the assessment and collection of property tax.
6	(c)(1) The findings and recommendations of the taskforce shall be
7	submitted to the legislative leaders, state department directors, and other
8	appropriate parties for collaborative reform.
9	(2) The taskforce shall report to the Joint Performance Review
10	Committee after each meeting of the task force.
11	(3) The taskforce shall make its final report to the Joint
12	Performance Review Committee no later than December 1, 2004.
