18 WHEREAS, Barney Reeves is a 1954 graduate of Magnolia High School, and
19 attended Southern State College in Magnolia, Arkansas, currently known as
20 Southern Arkansas University; and

22 WHEREAS, Mr. Reeves is a resident of Magnolia, Arkansas, and is
23 actively involved in civic and volunteer activities in his community and in
24 Arkansas; is a former member of the Magnolia PTA; is a former Little League
25 and Boys' Club volunteer; is a member of Central Baptist Church; is a former
26 member of the Dorcheat Community Rural Water Board, playing an instrumental
27 role in making the rural water available to the Dorcheat Community, which in
28 turn led to the creation of the Dorcheat Community Rural Water Board; and is
29 an International Jaycee Senator, #13941; and

31 WHEREAS, Mr. Reeves served as Columbia County Judge for six (6) years;
32 served as a Columbia County Justice of the Peace; served as a Columbia County
33 Auxiliary Deputy Sheriff; and was named Director of the Alcoholic Beverage
34 Control Enforcement Division on January 2, 1995;

36 WHEREAS, Mr. Reeves has served the State of Arkansas in his role as



1 Director of the Alcoholic Beverage Control Enforcement Division for nine (9)
2 years, and will be retiring on January 31, 2004; and

4 WHEREAS, Mr. Reeves is married to his wife of 48 years, Nelda Furlow
5 Reeves; has three sons, Gregory Jess Reeves, Anthony Cris Reeves, and Samuel
6 Marvin Reeves; and has seven (7) grandchildren; and

9 publicly recognize Mr. Reeves' many contributions to the State of Arkansas
10 and his local community,
