15 AN ACT TO CLARIFY THAT DISPLAYED

21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
22

23 SECTION 1. Arkansas Code § 5-68-502 is amended to read as follows:
24 5-68-502. Unlawful acts.

25 It shall be unlawful for any person, including, but not limited to, any
26 persons having custody, control, or supervision of any commercial
27 establishment, to knowingly:

28 (1)(A) Display the cover, binder, or external visible portion of
29 material which is harmful to minors in such a way that minors, as a part of
30 the invited general public, will be exposed to view such material.

31 (B) Provided, however, a person shall be deemed not to
32 have displayed material harmful to minors if the lower two-thirds (2/3) of
33 the material is not exposed to view and segregated in a manner that
34 physically prohibits access to the material by minors; or

35 (2)(A) Sell, furnish, present, distribute, allow to view, or
36 otherwise disseminate to a minor, with or without consideration, any material



1 which is harmful to minors.

2 (B) Provided, this prohibition shall not apply to:

3 (i) Any dissemination by a parent, guardian, or
4 relative within the third degree ~~or~~ of consanguinity of the minor; or

5 (ii) Any dissemination with the consent of a parent
6 or guardian of the minor; or

7 (3)(A) Present to a minor or participate in presenting to a
8 minor, with or without consideration, any performance which is harmful to a
9 minor.

10 (B) Provided, this prohibition shall not apply to:

11 (i) Any dissemination by a parent, guardian, or
12 relative within the third degree ~~or~~ of consanguinity of the minor; or

13 (ii) Any dissemination with the consent of a parent
14 or guardian of the minor.
