20	WHEREAS, Article II, Section 2 of the United States Constitution states
21	the President "shall nominate, and by and with the Advice and Consent of the
22	Senate, shall appoint Ambassadors, other public Ministers and Consuls, Judges
23	of the supreme Court, and all other Officers of the United States"; and
24	
25	WHEREAS, a high likelihood exists of at least one (1) vacancy occurring
26	on the United States Supreme Court during the 109^{th} Congress; and
27	
28	WHEREAS, a possibility exists of the need to elevate a sitting Justice
29	on the United States Supreme Court to the position of Chief Justice during
30	the 109 th Congress; and
31	
32	WHEREAS, activist judges on some federal courts have frustrated the
33	constitutional structure which prescribes that laws shall be written by
34	elected legislatures; and
35	
36	WHEREAS. President George W. Bush has expressed his commitment to



I	appoint federal judges who will strictly interpret the United States
2	Constitution; and
3	
4	WHEREAS, in the past, a minority of senators have used dilatory tactics
5	to prevent a Senate floor vote on several of President George W. Bush's
6	judicial nominees, all of whom were reported favorably by the United States
7	Senate Committee on the Judiciary,
8	
9	NOW THEREFORE,
10	BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE EIGHTY-FIFTH GENERAL
11	ASSEMBLY OF THE STATE OF ARKANSAS:
12	
13	THAT the House of Representatives of the State of Arkansas requests that
14	Arkansas' United States Senators move quickly to confirm all judicial
15	nominees by President George W. Bush to the United States Supreme Court.
16	
17	BE IT FURTHER RESOLVED that the House of Representatives of the State
18	of Arkansas requests that upon adoption of this resolution, the Chief Clerk
19	of the House of Representatives of the State of Arkansas shall transmit a
20	copy to each of Arkansas' United States Senators.
