19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. (a) The amount of the State Insurance Department Trust
22 Fund that may be used for distribution to fire departments under Section 2 of
23 Act 1583 of 2003 is limited to one million dollars (\$1,000,000).

24 (b) There is transferred from the State Insurance Department Trust
25 Fund to the General Revenue Fund Account of the State Apportionment Fund an
26 amount equal to eight million dollars (\$8,000,000) less the amount required
27 under Sections 1 and 2 of Act 1583 of 2003 as modified by subsection (a) of
28 this section.

29 (c) This section applies only to Fiscal Year 2004-05.

31 SECTION 2. EMERGENCY CLAUSE. It is found and determined by the
32 General Assembly of the State of Arkansas that this act places limits on the
33 use of funds from the State Insurance Department Trust Fund for Fiscal Year
34 2004-05 and transfers fund; that this act would be ineffective in
35 accomplishing its purpose if the act became effective after this fiscal year;
36 and that this act is immediately necessary in order to accomplish the



1 purposes of this act. Therefore, an emergency is declared to exist and this
2 act being immediately necessary for the preservation of the public peace,
3 health, and safety shall become effective on:

4 (1) The date of its approval by the Governor;

5 (2) If the bill is neither approved nor vetoed by the Governor,
6 the expiration of the period of time during which the Governor may veto the
7 bill; or

8 (3) If the bill is vetoed by the Governor and the veto is
9 overridden, the date the last house overrides the veto.
