24	BE IT RESOLVED BY THE SENATE OF THE EIGHTY-FIFTH GENERAL ASSEMBLY OF THE
25	STATE OF ARKANSAS AND BY THE HOUSE OF REPRESENTATIVES, A MAJORITY OF ALL
26	MEMBERS ELECTED TO EACH HOUSE AGREEING THERETO:

28	That the following is proposed as an amendment to the Constitution of
29	the State of Arkansas, and upon being submitted to the electors of the state
30	for approval or rejection at the next general election for Senators and
31	Representatives, if a majority of the electors voting thereon at the
32	election, adopt the amendment, the amendment shall become a part of the
33	Constitution of the State of Arkansas, to wit:

35	SECTION 1. (a) The General Assembly may by law establish criminal
36	penalties applicable to a person who issues or passes a check, order, draft,

1	or any other form of presentment involving the transmission of account
2	information for the payment of money in order to discharge a preexisting debt
3	if the person knows that the issuer does not have sufficient funds in or on
4	deposit with the bank or other drawee for the payment in full of the check,
5	order, draft, or any other form of presentment involving the transmission of
6	account information, as well as for all other checks, orders, drafts, or any
7	other forms of presentment involving the transmission of account information
8	outstanding at the time of issuance.
9	(b) Other provisions of the Arkansas Constitution which may be in
10	conflict with this section shall not apply to this section.
11	
12	SECTION 2. EFFECTIVE DATE. This section shall become effective on
13	January 1, 2007.
