- SECTION 8. Arkansas Code § 24-2-701(c)(1), concerning employer
- 25 contribution rates for the Arkansas Teacher Retirement System, is amended to
- 26 read as follows:
- 27 (1)(A) For the Arkansas Teacher Retirement System, for the
- 28 fiscal years ending June 30, 2006, and June 30, 2007, the Board of Trustees
- 29 of the Arkansas Teacher Retirement System shall establish employer
- 30 contribution rates prospectively each year.
- 31 (B) The employer contribution rates shall be based on the
- 32 actuary's determination of the rate required to fund the plan in accordance
- 33 with the objectives set forth in subsection (a) of this section.
- 34 (C) The employer contribution rates shall be the rates
- 35 determined by the Board of Trustees of the Arkansas Teacher Retirement System
- 36 based on the annual actuarial valuation.

1	(D) For the fiscal year <u>years</u> ending June 30, 2006, <u>and</u>
2	June 20, 2007, the employer contribution rate shall not exceed fourteen
3	percent (14%).
4	(E) For the fiscal year ending June 30, 2007, the employer
5	contribution rate shall not be increased by more than one percent (1%) above
6	the rate in effect on June 30, 2006.

8	SECTION 9. Arkansas Code § 24-7-401(c), concerning employer
9	contribution rates for the Arkansas Teacher Retirement System, is amended to
10	read as follows:
11	(c)(1) For the fiscal years ending June 30, 2006, and June 30, 2007,
12	the Board of Trustees of the Arkansas Teacher Retirement System shall
13	establish employer contribution rates for the system prospectively each year.
14	(2) The employer contribution rates shall be based on the
15	actuary's determination of the rate required to fund the plan in accordance
16	with the objectives stated in subsection (a) of this section.
17	(3) The employer contribution rates shall be the rates
18	determined by the board based on the annual actuarial valuation.
19	(4) For the fiscal year years ending June 30, 2006, and June 30,
20	2007, the employer contribution rate shall not exceed fourteen percent (14%).
21	(5) For the fiscal year ending June 30, 2007, the employer
22	contribution rate shall not be increased by more than one percent (1%) above
23	the rate in effect on June 30, 2006.
24	
25	SECTION 10. EMERGENCY CLAUSE. It is found and determined by the
26	General Assembly of the State of Arkansas that the Arkansas Supreme Court
27	declared the public school funding system to be inadequate and that public
28	schools are operating under a constitutional infirmity which must be
29	corrected immediately; that to correct the constitutional infirmity and to
30	ensure adequate funding for public education, the General Assembly must
31	revise the public school funding formula, revise laws regarding public school
32	facilities, provide funding for retirement increases and limit additional
33	increases; and enact other necessary reform measures; and that this act is
34	immediately necessary to ensure that reform measures are available to public
35	schools for the 2005-2006 and 2006-2007 school years. Therefore, an
36	emergency is declared to exist and this act being immediately necessary for

1	the preservation of the public peace, health, and safety shall become
2	<pre>effective on:</pre>
3	(1) The date of its approval by the Governor;
4	(2) If the bill is neither approved nor vetoed by the Governor,
5	the expiration of the period of time during which the Governor may veto the
6	bill; or
7	(3) If the bill is vetoed by the Governor and the veto is
8	overridden, the date the last house overrides the veto.
