10 SERVICES AND OPERATING EXPENSES FOR THE WAR  
11 MEMORIAL STADIUM COMMISSION FOR THE BIENNIAL  
12 PERIOD ENDING JUNE 30, 2009; AND FOR OTHER  
13 PURPOSES.

16 AN ACT FOR THE WAR MEMORIAL STADIUM  
17 COMMISSION APPROPRIATION FOR THE  
18 2007-2009 BIENNIUM.

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
23

24 SECTION 1. REGULAR SALARIES - OPERATIONS. There is hereby established for  
25 the War Memorial Stadium Commission for the 2007-2009 biennium, the following  
26 maximum number of regular employees whose salaries shall be governed by the  
27 provisions of the Uniform Classification and Compensation Act (Arkansas Code  
28 §§21-5-201 et seq.), or its successor, and all laws amendatory thereto.  
29 Provided, however, that any position to which a specific maximum annual  
30 salary is set out herein in dollars, shall be exempt from the provisions of  
31 said Uniform Classification and Compensation Act. All persons occupying  
32 positions authorized herein are hereby governed by the provisions of the  
33 Regular Salaries Procedures and Restrictions Act (Arkansas Code §21-5-101),  
34 or its successor.

13 SECTION 2. EXTRA HELP - OPERATIONS. There is hereby authorized, for the  
 14 War Memorial Stadium Commission for the 2007-2009 biennium, the following  
 15 maximum number of part-time or temporary employees, to be known as "Extra  
 16 Help", payable from funds appropriated herein for such purposes: one hundred  
 17 fifty (150) temporary or part-time employees, when needed, at rates of pay  
 18 not to exceed those provided in the Uniform Classification and Compensation  
 19 Act, or its successor, or this act for the appropriate classification.

21 SECTION 3. APPROPRIATION - STATE OPERATIONS. There is hereby appropriated,  
 22 to the War Memorial Stadium Commission, to be payable from the Miscellaneous  
 23 Agencies Fund Account, for personal services, operating expenses, major  
 24 maintenance, renovation of facilities and scoreboards, and repairs of the War  
 25 Memorial Stadium Commission for the biennial period ending June 30, 2009, the  
 26 following:

 6 SECTION 4. APPROPRIATIONS - CASH OPERATIONS. There is hereby  
 7 appropriated, to the War Memorial Stadium Commission, to be payable from cash  
 8 funds as defined by Arkansas Code 19-4-801 of the War Memorial Stadium  
 9 Commission, for personal services and operating expenses of the War Memorial  
 10 Stadium Commission for the biennial period ending June 30, 2009, the  
 11 following:

 31 SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
 32 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.  
 33 APPROPRIATION RESTRICTIONS - LAND ACQUISITION. In no event shall any funds  
 34 appropriated to the War Memorial Stadium Commission be used for the  
 35 acquisition of real estate without the prior review and approval of the  
 36 Arkansas Legislative Council or Joint Budget Committee.

1 Determining the maximum number of employees and the maximum amount of  
2 appropriation and general revenue funding for a state agency each fiscal year  
3 is the function of the General Assembly. This is usually accomplished by  
4 delineating such maximums as the appropriation in the appropriation act(s)  
5 for a state agency and the general revenue allocations authorized for each  
6 fund and fund account by amendment to the Revenue Stabilization law.  
7 Therefore, it is both necessary and appropriate that the General Assembly  
8 maintain oversight be requiring prior approval of the Legislative Council or  
9 Joint Budget Committee as provided by this section. The requirement of  
10 approval by the Legislative Council or Joint Budget Committee is not a  
11 severable part of this section. If the requirement of approval be the  
12 Legislative Council or Joint Budget Committee is ruled unconstitutional by a  
13 court of competent jurisdiction, then the authority of the Commission to  
14 acquire real estate is void.

15 The provisions of this section shall be in effect only from July 1, 2007  
16 through June 30, 2009.

17  
18 SECTION 6. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
19 authorized by this act shall be limited to the appropriation for such agency  
20 and funds made available by law for the support of such appropriations; and  
21 the restrictions of the State Procurement Law, the General Accounting and  
22 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
23 Procedures and Restrictions Act, or their successors, and other fiscal  
24 control laws of this State, where applicable, and regulations promulgated by  
25 the Department of Finance and Administration, as authorized by law, shall be  
26 strictly complied with in disbursement of said funds.

27  
28 SECTION 7. LEGISLATIVE INTENT. It is the intent of the General Assembly  
29 that any funds disbursed under the authority of the appropriations contained  
30 in this act shall be in compliance with the stated reasons for which this act  
31 was adopted, as evidenced by the Agency Requests, Executive Recommendations  
32 and Legislative Recommendations contained in the budget manuals prepared by  
33 the Department of Finance and Administration, letters, or summarized oral  
34 testimony in the official minutes of the Arkansas Legislative Council or  
35 Joint Budget Committee which relate to its passage and adoption.
