1	The Office of Driver Services may issue a nonresident CDL to a resident		
2	of a foreign jurisdiction if the United States Secretary of Transportation		
3	has determined that the commercial motor vehicle testing and licensing		
4	standards in the foreign jurisdiction do not meet the testing standards		
5	established in 49 C.F.R., part 383 and if the nonresident applicant completes		
6	the requirements for the issuance of the applicable class of commercial		
7	driver license as required by this chapter. The word "Nonresident" must		
8	appear on the face of the nonresident CDL. An applicant must surrender any		
9	nonresident CDL issued by another state. Prior to issuing a nonresident CDL,		
10	the Office of Driver Services must establish the practical capability of		
11	revoking, suspending, or cancelling the nonresident CDL and disqualifying		
12	that person with the same conditions applicable to the commercial driver		
13	license issued to a resident of this state.
