- The provisions of this section shall be in effect only from July 1, 2007
- 20 2009 through June 30, 2009 2010.

- 22 SECTION 29. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
- 23 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL, AND TEMPORARY LAW. ARRA
- 24 APPROPRIATION RESTRICTIONS. Of the total funds appropriated in Section 10 of
- 25 this Act, a total of fifty million three hundred seventy-four thousand two
- 26 <u>hundred thirty-nine dollars (\$50,374,239) shall be used by the Department of</u>
- 27 Workforce Services for the payment of unemployment insurance benefits. The
- 28 remaining nine million five hundred ninety-five thousand eighty-three dollars
- 29 (\$9,595,083) shall be utilized by the Department of Workforce Services for
- 30 the payment of salaries and related benefits and maintenance and general
- 31 operation in support of and administration of the Unemployment Insurance (UI)
- 32 Modernization provisions adopted pursuant to the ARRA Stimulus Act of 2009.
- 33 Those funds specifically identified by this section for the payment of
- 34 salaries and related benefits and maintenance and general operation shall be
- 35 considered as obligations of the Department of Workforce Services for the
- 36 purpose of implementing and administering the UI Modernization provisions.

2	SECTION 30. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized
3	by this act shall be limited to the appropriation for such agency and funds
4	made available by law for the support of such appropriations; and the
5	restrictions of the State Procurement Law, the General Accounting and
6	Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
7	Procedures and Restrictions Act, or their successors, and other fiscal
8	control laws of this State, where applicable, and regulations promulgated by
9	the Department of Finance and Administration, as authorized by law, shall be
10	strictly complied with in disbursement of said funds.
11	
12	SECTION 31 . LEGISLATIVE INTENT. It is the intent of the General Assembly
13	that any funds disbursed under the authority of the appropriations contained
14	in this act shall be in compliance with the stated reasons for which this act
15	was adopted, as evidenced by the Agency Requests, Executive Recommendations
16	and Legislative Recommendations contained in the budget manuals prepared by
17	the Department of Finance and Administration, letters, or summarized oral
18	testimony in the official minutes of the Arkansas Legislative Council or
19	Joint Budget Committee which relate to its passage and adoption.
20	
21	SECTION 32. EMERGENCY CLAUSE. It is found and determined by the General
22	Assembly, that the Constitution of the State of Arkansas prohibits the
23	appropriation of funds for more than a one (1) year period; that the
24	effectiveness of this Act on July 1, 2009 is essential to the operation of
25	the agency for which the appropriations in this Act are provided, and that in
26	the event of an extension of the Regular Session, the delay in the effective
27	date of this Act beyond July 1, 2009 could work irreparable harm upon the
28	proper administration and provision of essential governmental programs.
29	Therefore, an emergency is hereby declared to exist and this Act being
30	necessary for the immediate preservation of the public peace, health and
31	safety shall be in full force and effect from and after July 1, 2009.
