22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
23

24 SECTION 1. REGULAR SALARIES. There is hereby established for the
25 Department of Workforce Services for the 2009-2010 fiscal year, the following
26 maximum number of regular employees whose salaries shall be governed by the
27 provisions of the Uniform Classification and Compensation Act (Arkansas Code
28 §§21-5-201 et seq.), or its successor, and all laws amendatory thereto.
29 Provided, however, that any position to which a specific maximum annual
30 salary is set out herein in dollars, shall be exempt from the provisions of
31 said Uniform Classification and Compensation Act. All persons occupying
32 positions authorized herein are hereby governed by the provisions of the
33 Regular Salaries Procedures and Restrictions Act (Arkansas Code §21-5-101),
34 or its successor.

9 SUSPENSION OR REDUCTION OF FUNDS APPROPRIATED TO THE COMMUNITY INVESTMENT
 10 INITIATIVE. Spending for the Community Investment Initiative can be
 11 suspended or reduced if the Director of the Department of Workforce Services
 12 and the Transitional Employment Board certify that

- 13 a) Funding from the Temporary Assistance for Needy Families block grant is
- 14 needed to support a critical economic development initiative,
- 15 b) Other funds from the Temporary Assistance for Needy Families block
- 16 grant are not available beyond those needed for the operation of the TEA,
- 17 Work Pays and High Wage Education and Training Programs and for an adequate
- 18 reserve for possible increases in cash assistance during the current fiscal
- 19 year, and
- 20 c) Spending for the economic development initiative is allowable within

34 HELP. There is hereby authorized, for the Department of Workforce Services

12 FUNDS". Funds received by the State may be used as specified in 903 of the
13 Social Security Act, for the purpose of construction and improvement of

15 related benefits of central and local office staff, maintenance and operation
16 of central and local offices, payment of unemployment insurance benefits, or
17 as otherwise prescribed in Section 903 of the Social Security Act, as

20 which (a) the aggregate of the amounts transferred to the account of this

29 ADDITIONAL POSITIONS. The Director of the Department of Workforce Services,
30 after receiving the approval of the Office of Personnel Management, and after
31 seeking the prior review by the Arkansas Legislative Council, shall have the
32 authority to establish such new or additional full time positions as may
33 become necessary to carry out the objectives of the program and/or to meet
34 Federal requirements of new and/or expanded programs where such needs are

10 SECTION 26. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
11 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER
12 OF APPROPRIATION. Subject to such rules and regulations as may be
13 implemented by the Chief Fiscal Officer of the State and after having sought
14 the prior approval by the Arkansas Legislative Council or Joint Budget
15 Committee, the Director of the Department of Workforce Services is hereby
16 authorized to make transfers from any appropriation made by this Act to any
17 other appropriation made by this Act with the exception of the "Reed Act
18 Funds" appropriations set forth in *Sections 9 and 10* of this Act, and of the
19 appropriation made for Regular Salaries or Maintenance and General Operation.
20 Such transfers may be made whenever it appears, by projecting the
21 expenditures of any of the appropriations in this Act, that there will be a
22 deficiency of appropriation in one item and that there will be a
23 corresponding excess of appropriation in another item or items which may be
24 transferred. The transfer of appropriation shall be effected only on
25 approval of the Chief Fiscal Officer of the State. Provided, however, that no

29 Determining the maximum number of employees and the maximum amount of

33 the general revenue allocations authorized for each fund and fund account by
34 amendment to the Revenue Stabilization law. Further, the General Assembly

16 Department of ~~Health and~~ Human Services and the Director of the Department of
17 Workforce Services (DWS), the Chief Fiscal Officer of the State may approve
18 up to three million six hundred forty thousand six hundred fifty dollars
19 (\$3,640,650) each fiscal year in State General Revenue appropriated to DWS
20 for the TANF program to be transferred to the Department of ~~Health and~~ Human
21 Services ~~(DHS)~~ (DHS) - Division of County Operations in support of Arkansas'
22 Temporary Assistance for Needy Families (TANF) Programs or any related
23 separate state programs.

24 The Director of the Department of Workforce Services shall provide a

34 OF TANF BLOCK GRANT FUNDS. ~~For each~~ Each fiscal year ~~of the 2007-2009~~
35 ~~biennium~~, the Department of Workforce Services shall transfer the sum of
36 seven million five hundred thousand dollars (\$7,500,000) from the state's

1 federal Temporary Assistance for Needy Families block grant to the Child Care
2 Development Fund to be administered by the Division of Child Care and Early
3 Childhood Education, Department of Health and Human Services. The funds shall
4 be used to provide quality child care and preschool education for
5 transitional employment assistance qualifying families and other low-income
6 families for at-risk three- and four-year-olds under the Arkansas Better
7 Chance for School Success programs. These funds shall be transferred from the
8 Division of Child Care and Early Childhood Education to the Department of
9 Education, Public School Fund to be used solely for the purpose stated above
10 Arkansas Better Chance Program.

23 *CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL, AND TEMPORARY LAW. ARRA*
24 *APPROPRIATION RESTRICTIONS. Of the total funds appropriated in Section 10 of*
25 *this Act, a total of fifty million three hundred seventy-four thousand two*
26 *hundred thirty-nine dollars (\$50,374,239) shall be used by the Department of*
27 *Workforce Services for the payment of unemployment insurance benefits. The*
28 *remaining nine million five hundred ninety-five thousand eighty-three dollars*
29 *(\$9,595,083) shall be utilized by the Department of Workforce Services for*
30 *the payment of salaries and related benefits and maintenance and general*

SECTION 30. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and the restrictions of the State Procurement Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of said funds.

SECTION 31. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 32. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a one (1) year period; that the effectiveness of this Act on July 1, 2009 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the Regular Session, the delay in the effective date of this Act beyond July 1, 2009 could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 2009.
