3	(b) The fund shall consist of one-quarter (1/4) of the revenues
4	received under § 27-32-115.

6	19-6-812. Community Health Centers Fund.
7	(a)(1) There is created on the books of the Treasurer of State, the
8	Auditor of State, and the Chief Fiscal Officer of the State a special revenue
9	fund to be known as the "Community Health Centers Fund".
10	(2) The fund shall be managed by the Department of Health.
11	(3) The fund shall be used to fund community health centers in
12	Arkansas.
13	(b) The fund shall consist of one-quarter (1/4) of the revenues
14	received under § 27-32-115.
15	
16	19-6-813. Non-Medicare Primary Retiree Fund.
17	(a)(1) There is created on the books of the Treasurer of State, the
18	Auditor of State, and the Chief Fiscal Officer of the State a special revenue
19	fund to be known as the "Non-Medicare Primary Retiree Fund".
20	(2) The fund shall be managed by the Employee Benefits Division
21	of the Department of Finance and Administration.
22	(3) The fund shall be used to assist active public school
23	retirees that are not eligible for Medicare with the costs of insurance
24	payments.
25	(b) The fund shall consist of one-quarter (1/4) of the revenues
26	received under § 27-32-115.
27	
28	SECTION 2. Arkansas Code Title 27, Chapter 32, Subchapter 1 is amended
29	to read as follows:
30	27-32-101. Vehicles to be in safe mechanical condition. Chapter not
31	applicable to certain vehicles.
32	(a)(1) No person shall drive or move any vehicle subject to
33	registration on any highway in this state unless the equipment on the vehicle
34	is in good working order and adjustment as required for the vehicle's safe
35	operation and unless the vehicle is in safe mechanical condition as not to
36	andanger the driver other occupants of the vehicle or any other person

1	(2)(A) Any law enforcement officer having reason to believe that
2	a vehicle may have safety defects shall have cause to stop the vehicle and
3	inspect for safety defects.
4	(B) Should the officer determine that the vehicle is
5	defective, he or she shall issue to the operator a safety compliance summons
6	directing the operator to have the defect corrected.
7	(b) Any certified police officer upon reasonable cause to believe that
8	a motor vehicle is unsafe or not equipped as required by law or that its
9	equipment is not in proper adjustment or repair require the driver of the
10	motor vehicle to stop and submit the vehicle to an inspection and test as may
11	<del>be appropriate.</del>
12	(c) In the event that the use of a vehicle in its present condition
13	would, in the reasonable judgment of the officer, endanger the life of any
14	member of the public, the officer may issue to the operator a citation for
15	operating an unsafe vehicle and may require the vehicle to be parked at the
16	owner's expense and not operated until it is made safe.
17	(d) The intent of this section is to make the vehicle operator aware
18	of any vehicle safety defects and to provide the operator a reasonable
19	opportunity to make necessary repairs without requiring the issuance of a
20	citation which may result in the levying of fines and court costs.
21	(a) This chapter does not apply to:
22	(1) Motor vehicles that are:
23	(A) Operating under the safety regulations and meeting the
24	safety standards of the United States Department of Transportation;
25	(B) Part of a municipally owned and operated system; or
26	(C) Forty (40) years old and used primarily for exhibition
27	in shows, parades, tours, and other special uses and not for general
28	transportation;
29	(2) Trailers and semitrailers having a gross loaded weight of
30	three thousand pounds (3,000 lbs) or less;
31	(3) Trailers and semitrailers, not for hire, used primarily for
32	hauling farm products; and
33	(4) House trailers not operated upon the public highways.
34	
35	27-32-102. Penalty for operating an unsafe vehicle. Penalties.
36	Any person found quilty of operating an uncafe vehicle shall be subject

1	to a fine of not less than twenty-five dollars (\$25.00) nor more than two
2	hundred fifty dollars (\$250).
3	(a)(1) A person shall not:
4	(A) Make, issue, or knowingly use an imitation or
5	counterfeit of an official certificate of inspection;
6	(B) Display or cause or permit to be displayed upon a
7	motor vehicle a certificate of inspection and approval knowing it to be
8	fictitious or issued without the vehicle's having first been properly
9	inspected as required by this chapter;
10	(C) Mutilate a valid certificate of inspection and
11	approval or rejection; or
12	(D) Remove the certificate of inspection and approval from
13	a motor vehicle.
14	(2) A violation of subdivision (a)(1) of this section is a
15	violation pursuant to § 5-1-108 and upon conviction a person shall be fined
16	not less than twenty dollars (\$20.00) nor more than two hundred dollars
17	<u>(\$200).</u>
18	(b)(1) A person shall not:
19	(A) Display or cause or permit to be displayed a sign,
20	mark, or advertisement as an official inspection station or official
21	individual inspector unless a license has been issued by the Director of the
22	Department of Arkansas State Police and is in effect;
23	(B) Transfer or attempt to transfer a license for an
24	official inspection station or official individual inspector; or
25	(C) Make a false statement on an application for a license
26	for an official inspection station, official individual inspector, or for
27	renewal of such a license.
28	(2) A violation of subdivision (b)(l) of this section is a
29	violation pursuant to § 5-1-108 and upon conviction a person shall be fined
30	not less than fifty dollars (\$50.00) nor more than five hundred dollars
31	<u>(\$500)</u> .
32	
33	27-32-103. Motor vehicles to be in safe mechanical condition.
34	A person shall not drive or move on any highway any motor vehicle,
35	trailer, semitrailer, or pole trailer unless the:
36	(1) Equipment upon the motor vehicle, trailer, semitrailer, or

1	pole trailer is in good working order; and
2	(2) Motor vehicle, trailer, semitrailer, or pole trailer is in a
3	safe mechanical condition so as not to endanger the driver or other occupant
4	or any person upon the highway.
5	
6	27-32-104. Inspections to be made on staggered basis.
7	The Director of the Arkansas State Police shall provide, by rule, for
8	the official inspection and issuance of a certificate of inspection and
9	approval:
10	(1) Based upon:
11	(A) The last digit on license plates;
12	(B) Rotation by alphabetical listing of owner's last name;
13	<u>or</u>
14	(C) Another staggered basis; and
15	(2) Upon payment of the required fee and compliance with the
16	other provisions of this chapter.
17	
18	27-32-105. Extensions of time for inspections.
19	With the approval of the Governor, the Director of the Department of
20	the Arkansas State Police may extend the time for not more than sixty (60)
21	days for any of the inspections required by this chapter if weather
22	conditions of the highways or any other cause renders compliance with this
23	chapter within the prescribed time difficult or impossible for a large number
24	of persons.
25	
26	27-32-106. Inspection required before registration and licensing.
27	A motor vehicle, trailer, semitrailer, or pole trailer shall not be
28	registered or licensed under the laws of this state by the Director of the
29	Department of Finance and Administration unless the motor vehicle, trailer,
30	semi-trailer, or pole trailer for which the license is sought is inspected
31	under this chapter:
32	(1) At the time of receipt of the notice for renewal of
33	registration; or
34	(2) Within thirty (30) days immediately before making
35	application for licensing or relicensing of the motor vehicle, trailer, semi-
36	trailer or nole trailer

1	
2	27-32-107. Inspection required on sale or transfer.
3	(a) Every motor vehicle, trailer, semitrailer, and pole trailer
4	registered in this state and subsequently sold or transferred shall have a
5	new or current official certificate of inspection and approval if the annual
6	inspection for safety on the motor vehicle, trailer, semi-trailer, or pole
7	trailer was conducted more than thirty (30) days before the transfer or sale.
8	(b) A motor vehicle, trailer, semitrailer, or pole trailer shall not
9	be operated upon a public street or highway for more than twenty (20) days
10	after the transfer date unless a valid certificate of inspection and approval
11	is properly attached.
12	
13	27-32-108. Annual inspection required.
14	(a)(1) Every motor vehicle, trailer, semitrailer, and pole trailer
15	registered in this state shall be annually inspected for safety.
16	(2) An official certificate of inspection and approval shall be
17	obtained for each motor vehicle, trailer, semitrailer, and pole trailer.
18	(b)(1)(A) Inspection shall be made and certificates of inspection and
19	approval obtained with respect to the brakes, lights, turn signals, if any,
20	steering, sound devices, glass, mirror, exhaust system, windshield wipers,
21	tires, and other items of equipment as the Director of the Department of
22	Arkansas State Police determines.
23	(B) The inspection of tires and wheel alignment required
24	in this chapter shall be a visual inspection only.
25	(2)(A) If the person making the inspection finds that there is
26	more than one (1) crack or other visual impairment in an eight inches (8")
27	wide area running horizontally through the center of the windshield that
28	falls under the windshield wiper area on the driver's side, that motor
29	vehicle, trailer, semitrailer, and pole trailer shall not be issued a
30	certificate of inspection until the crack or other visual impairment has been
31	corrected.
32	(B) Any decision resulting in failure to issue a
33	certificate of inspection due to faulty glass may be appealed to the
34	Department of Arkansas State Police.
35	(c)(l) If the repair or adjustment of a motor vehicle, trailer,
36	semitrailer, and pole trailer or its equipment is found necessary upon

T	inspection, the owner of the motor vehicle, trailer, semitralier, and pole
2	trailer may obtain the repair or adjustment at any place he or she chooses
3	within ten (10) days after the inspection.
4	(2) An official certificate of inspection and approval shall be
5	obtained from an official permit holder within ten (10) days before the motor
6	vehicle, trailer, semitrailer, and pole trailer is operated upon the highways
7	of this state.
8	(3) The fee shall be collected at the time of the original
9	inspection.
10	(4) An additional fee shall not be charged if the motor vehicle,
11	trailer, semitrailer, and pole trailer is repaired and returned to the same
12	inspection station within ten (10) days.
13	(d) On proper notice by the department, the Office of Motor Vehicle
14	shall suspend the registration of any vehicle:
15	(1) That is determined to be in such unsafe condition as to
16	constitute a menace to safety;
17	(2) That, after notice and demand, is not equipped as required
18	by this chapter; or
19	(3) For which a required certificate of inspection and approval
20	has not been obtained.
21	(e) The director may:
22	(1) Authorize by rule the acceptance in this state of a
23	certificate of inspection and approval issued in another state having an
24	inspection law similar to this state: and
25	(2) Extend the time within which a certificate of inspection and
26	approval shall be obtained by the resident owner of a vehicle which was not
27	in this state during the time an inspection was required.
28	
29	27-32-109. Permits for official inspection stations.
30	(a)(1) The Department of Arkansas State Police shall administer the
31	program for the inspection of motor vehicle, trailer, semitrailer, and pole
32	trailer established under this chapter.
33	(2) The department shall issue permits for and furnish
34	instructions and all necessary forms to official inspection stations for the
35	inspection of motor vehicle, trailer, semitrailer, and pole trailer as
36	required by this chapter.

1	(3) The official certificates of inspection and approval shall be
2	obtained from the department at a cost of one dollar and fifty cents (\$1.50)
3	per certificate.
4	(b)(1) An annual fee set by rule of the department shall not exceed
5	one hundred dollars (\$100) and shall accompany the application for a permit.
6	(2) If a permit is not issued, one-half $(1/2)$ of the fee shall
7	be returned to the applicant.
8	(c) Application for a permit for an official inspection station shall
9	be made upon an official form and shall be granted if the department is
10	satisfied that the garage, service station, or shop of the applicant is
11	properly equipped and has competent personnel to make safety inspections and
12	that the inspections will be properly conducted.
13	(d) Before issuing a permit for an official inspection station, the
14	director may require the applicant to file a bond conditioned that the
15	applicant will make compensation for any damage to a motor vehicle, trailer,
16	semitrailer, and pole trailer during an inspection or adjustment due to
17	negligence on the part of the applicant or its employees.
18	(e)(1) The director shall supervise and cause inspections to be made
19	of the official inspection stations and shall revoke the permit issued to an
20	official inspection station that he or she finds is not properly conducted.
21	(2) The department shall maintain lists of an official
22	inspection station holding permits and of those whose permits have been
23	revoked.
24	(f) The director shall revoke the permit issued to an official
25	inspection station upon the written request of the official inspection
26	station and only after all signs or posters pertaining to the safety
27	inspection program used by an official inspection station are removed from a
28	conspicuous place on the premises.
29	(g) A permit for an official inspection station:
30	(1) Shall not be assigned or transferred or used at any location
31	other than designated; and
32	(2) Shall be posted in a conspicuous place at the location
33	designated.
34	(h) The department shall issue a permit under this chapter to:
35	(1) Any operator of five (5) or more commercial vehicles who
36	carried out a safety program meeting the approval of the department; and

1	(2) Any franchised dealer in new motor vehicles.
2	
3	27-32-110. Operation of official inspection stations.
4	(a) A person shall not represent any place as an official inspection
5	station unless the inspection station is operating under a valid permit
6	issued by the department.
7	(b) All signs or posters pertaining to the safety inspection program
8	to be used by an official inspection station shall be approved by the
9	Department of Arkansas State Police before being distributed or posted.
10	(c) A certificate of inspection and approval shall be issued only by:
11	(1) A person other than an authorized permit holder; or
12	(2) An appointed employee of the permit holder.
13	
14	27-32-111. Issuance of certificates of inspection and approval.
15	(a)(1) The person operating an official inspection station shall issue
16	a certificate of inspection and approval upon an official form furnished by
17	the Department of Arkansas State Police to the owner of a vehicle only upon
18	inspecting the vehicle and determining that its equipment required by this
19	chapter is in good condition and proper adjustment.
20	(2) A record and report shall be made of every inspection and
21	every certificate of inspection and approval issued.
22	(3) The records required by this subsection shall be forwarded
23	to the department as required by rule.
24	(b)(1) Except as provided in subdivision (b)(2) of this section, the
25	fee for the inspection, including the issuance of the certificate of
26	approval, shall be ten dollars (\$10.00).
27	(2)(A) The fee for inspection, including the issuance of the
28	certificate of inspection approval, for all motor trucks, trailers,
29	$\underline{\text{semitrailers}}, \text{ and pole trailers with a gross loaded weight in excess of } \underline{\text{eight}}$
30	thousand pounds (8,000 lbs) shall be established by rule by the department.
31	(B) The fee under subdivision (b)(2) of this section shall
32	not less than ten dollars (\$10.00) nor more than thirty dollars (\$30.00) per
33	inspection.
34	(c) A certificate of inspection and approval shall not be issued until
35	the inspection is completed and the permit holder has complied with this
36	chapter.

1	(d)(1) At the conclusion of each inspection of a motor vehicle by the
2	person performing the inspection, the appropriate certificate of inspection
3	and approval shall be placed in the lower left-hand portion of the front
4	windshield on the driver's side in a place that shall not obstruct the vision
5	of the driver.
6	(2) Upon the inspection of a motorcycle, the certificate of
7	inspection and approval shall be placed in the appropriate space on the
8	license plate.
9	
10	27-32-112. Restrictions on certificates of inspection and approval.
11	(a) A person shall not make, issue, or knowingly use any imitation or
12	counterfeit of an official certificate of inspection.
13	(b) A person shall not display or cause or permit to be displayed upon
14	any vehicle any certificate of inspection and approval knowing the
15	certificate of inspection and approval to be:
16	(1) Fictitious;
17	(2) Issued for another vehicle; or
18	(3) Issued without an inspection having been made.
19	(c) An unauthorized person shall not knowingly possess vehicle
20	inspection stickers.
21	
22	27-32-113. Authority to stop vehicles for inspection and test.
23	(a) The Director of the Department of Arkansas State Police, uniformed
24	officers and troopers of the department, other officers and employees of the
25	department, and any other peace officer as the director may designate may
26	require the driver of the motor vehicle to stop and submit the vehicle to an
27	inspection and test if there is reasonable cause to believe that:
28	(1) The motor vehicle is unsafe;
29	(2) the motor vehicle is not equipped as required by law; or
30	(3) The motor vehicle's equipment is not in proper adjustment or
31	repair.
32	(b)(l) If a motor vehicle with a valid inspection sticker is found to
33	be in unsafe condition or any required part or equipment is not present or is
34	not in proper repair and adjustment, the officer shall give a written notice
35	to the driver and shall send one (1) copy to the Department of Arkansas State
36	Police.

1	(2)(A) The notice under subdivision (b)(1) of this section shall
2	require that the motor vehicle be placed in safe condition and its equipment
3	in proper repair and adjustment within a period of five (5) days.
4	(B) Upon the expiration of the five-day period under
5	subdivision (b)(2)(A) of this section, the motor vehicle shall not operate on
6	the highways until the motor vehicle is repaired and placed in a safe
7	condition.
8	(c) A person driving a motor vehicle shall not refuse to submit his or
9	her vehicle to an inspection and test when required to do so by the director,
10	an authorized employee of the department, or an authorized peace officer.
11	(d) A person shall not operate any motor vehicle after receiving a
12	notice as provided in subsection (b) of this section except as may be
13	necessary to return the motor vehicle to the residence or place of business
14	of the owner or driver or to a garage until the motor vehicle and its
15	equipment have been placed in proper repair and adjustment and otherwise made
16	to conform to this chapter.
17	(e) If the repair or adjustment of a motor vehicle or its equipment is
18	found necessary upon inspection, the owner of the motor vehicle may obtain
19	repair or adjustment at any place he or she chooses.
20	(f) If the use of a motor vehicle in its present condition would
21	endanger the life of any member of the public, the officer shall require the
22	motor vehicle to be parked at the owner's expense and not be operated until
23	it is placed in a safe condition.
24	
25	27-32-114. Rules.
26	The Director of the Department Arkansas State Police may make all
27	necessary rules for the administration and enforcement of this chapter.
28	
29	27-32-115. Disposition of fees.
30	(a) Other than amounts collected for the purchase of certificates of
31	inspection and approval and penalties, all fees that are collected by the
32	Department of Arkansas State Police under this chapter shall be special
33	revenues and shall be deposited into the State Treasury to the credit of the
34	Non-Medicare Primary Retiree Fund, the Autism Support Fund, and the Community
35	Health Centers Fund.
36	(h) As provided in § $27-32-102(a)(2)$ and (h)(2) and § $27-32-109(a)(3)$

1	the amounts collected by the department for the purchase of certificates of
2	inspection and approval shall be deposited into the State Treasury to the
3	credit of the Department of Arkansas State Police Fund to be used to defray
4	the cost of administering this chapter and for the support of the department
5	
6	27-32-116. Motorcycle safety inspection decals.
7	(a) The motor vehicle safety inspection decals for motorcycles shall
8	be designed to fit within a space on the license plate designated for that
9	purpose.
10	(b) The Director of the Department of Arkansas State Police, by rule,
11	may make any necessary changes in the design of the motor vehicle safety
12	inspection decals for motorcycles.
