26	20-27-2101. Definitions.		
27	As used in this subchapter:		
28	(1) "Consumer" means an individual	who is provided access to	<u>a</u>
29	tanning facility;		
30	(2)(A) "Operator" means an individ	lual designated by the tanni	ng
31	facility owner or tanning equipment lessee to o	perate or to assist and	
32	instruct the consumer in the operation and use of the tanning facility or		
33	tanning equipment.		
34	(B) However an operator in an apartment or a condominium		
35	need not exercise direct supervision or be physically on the premises at all		
36	times;		

1	(3) "Person" means an individual, corporation, partnership,	
2	limited liability company, firm, association, trust, estate, public or	
3	private institution, group, agency, political subdivision of this state, any	
4	other state, or political subdivision or agency of this state, and any legal	
5	successor, representative, agent, or agency of these entities;	
6	(4) "Tanning equipment" means ultraviolet or other lamps and	
7	equipment containing these lamps intended to induce skin tanning through the	
8	irradiation of any part of the living human body with ultraviolet radiation;	
9	(5)(A) "Tanning facility" means a location, place, area,	
10	structure, or business or a part of a location, place, area, structure, or	
11	business which provides consumers access to tanning equipment.	
12	(B) "Tanning facility" includes, without limitation	
13	regardless of whether a fee is charged for access to the tanning equipment:	
14	(i) Apartments;	
15	(ii) Condominiums;	
16	(ii) Health clubs; and	
17	(iv) Tanning salons; and	
18	(6) "Ultraviolet radiation" means electromagnetic radiation with	
19	wavelengths in air between two hundred nanometers (200 nm) and four hundred	
20	nanometers (400 nm).

22	20-27-2102. Consent required.	
23	Before allowing an initial exposure at a tanning facility of a person	
24	under eighteen (18) years of age, the owner or operator shall witness the	
25	person's parent or legal guardian signing and dating a warning statement as	
26	follows:

28	"WARNING STATEMENT	
29	This statement must be read and signed by a parent or legal guardian of	
30	any person under eighteen (18) years of age before allowing the initial	
31	exposure at this tanning facility.	
32	DANGER — ULTRAVIOLET RADIATION WARNING	
33	Follow instructions.	
34	Avoid overexposure. As with natural sunlight, overexposure can cause	
35	eye and skin injury and allergic reactions. Repeated exposure may cause	
36	premature aging of the skin and skin cancer.	

1	Wear protective eyewear. FAILURE TO USE PROTECTIVE EYEWEAR MAY RESULT		
2	IN SEVERE BURNS OR LONG-TERM INJURY TO THE EYES.		
3	Medications or cosmetics may increase your sensitivity to the		
4	ultraviolet radiation. Consult a physician before using sunlamp or tanning		
5	equipment if you are using medications or have a history of skin problems o		
6	believe yourself to be especially sensitive to sunlight.		
7	I have read the above warning and understand what it means before		
8	undertaking any tanning equipment exposure.
