1 GENERAL ASSEMBLY AND TO PROVIDE FOR A 2 RECESS OF THE GENERAL ASSEMBLY. 3 4 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE EIGHTY-SEVENTH GENERAL 5 6 ASSEMBLY OF THE STATE OF ARKANSAS, THE SENATE CONCURRING THEREIN: 7 8 That the Regular Session of the Eighty-Seventh General Assembly of (a) 9 the State of Arkansas is extended until 12:00 noon, May 1, 2009; 10 That under Arkansas Constitution, Article 6, § 15, prior to (b) 11 adjournment of the General Assembly, the Governor is afforded five days after 12 receipt of a bill to sign a bill or veto a bill, therefore from April 10, 13 2009 to May 1, 2009, the House Representatives and the Senate shall be open 14 so the office of the Chief Clerk of the House of Representatives and the 15 office of the Secretary of the Senate may receive communications, vetoes of 16 bills by the Governor, and notification of errors and oversights; 17 That the Regular Session of the Eighty-Seventh General Assembly of (c) the State of Arkansas shall enter into recess simultaneously at the close of 18 19 business in each chamber on April 10, 2009, or at such earlier time as may be agreed upon by the House of Representatives and the Senate; 20 21 (d) That the Speaker of the House of Representatives and the President 22 Pro Tempore of the Senate may, by joint proclamation: 23 (1) Reconvene the General Assembly at any time before 12:00 24 noon, May 1, 2009, for the purpose of: 25 (A) Considering vetoes; 26 (B) Correcting errors and oversights; 27 (C) Completing its work on proposed constitutional 28 amendments; 29 (D) Considering any issues that may arise from the passage 30 of the federal stimulus package; and 31 (E) Considering the need for further extension of the 32 Regular Session of the Eighty-Seventh General Assembly; or 33 (2) Adjourn the Regular Session of the Eighty-Seventh General 34 Assembly at any time before 12:00 noon, May 1, 2009, if they determine it is 35 not necessary to reconvene; and 36 (e) That if the General Assembly is not reconvened or adjourned before
