9 (B) If the person has participated in the fund for at 10 least twenty (20) years, the person contributes to the member's deposit 11 account a sum of money equal to the amount of the combined employee and 12 employer contribution made to the system based upon contributions at the time 13 the person first became a member of the retirement system, multiplied by the 14 number of months of military service the member is eligible for and desires 15 to purchase under this section, plus interest on the amount at the rate of 16 six percent (6%) per annum from the date of eligibility to purchase the 17 service to the date of purchase.
