1	SECTION 2. Arkansas Code § 14-20-10/(e)(3), concerning the Automated
2	Records Systems Fund Committee, is amended to read as follows:
3	(3)(A) The Automated Records Systems Fund shall be administered
4	by a committee composed of the county recorders of the counties in Class 6
5	and Class 7 to be known as the "Automated Records Systems Fund Committee".
6	(B) The committee shall meet biannually to review grant
7	applications made by county recorders in Class $1-$ Class 5 solely for
8	purposes directly related to office automation.
9	(C) The committee shall not disburse any moneys from the
10	Automated Records Systems Fund to counties in Class 6 and Class 7.
11	(D) The committee shall expend substantially all of the
