10 AUTHORITY OF THE ARKANSAS TOWING AND RECOVERY

14 TO CLARIFY THE DUTIES, COMPOSITION, AND
15 AUTHORITY OF THE ARKANSAS TOWING AND
16 RECOVERY BOARD.

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
20

21 *SECTION 1. Arkansas Code § 27-50-1203(a)(2), regarding the Arkansas*
22 *Towing and Recovery Board, is amended to read as follows:*

23 *(2)(A) Four (4) members shall be appointed from the towing*
24 *industry and shall be licensed by the board to engage in nonconsent towing,*
25 *with one (1) each of the members being a resident of each of the four (4)*
26 *congressional districts.*

27 *(B) Two (2) members who are permitted to engage in the*
28 *consent-only business shall be appointed from the state at large.*

29 *(C) ~~Two (2) members~~ One (1) member who ~~are~~ is not*
30 *associated with the towing industry shall be appointed from the state at*
31 *large.*

32 *(D) One (1) member shall be appointed from the insurance*
33 *industry.*

34 *(E) One (1) member shall be engaged in the trucking*
35 *industry and shall be selected from a list of six (6) names submitted by the*
36 *Arkansas Trucking Association.*

2 SECTION 2. NOT TO BE CODIFIED. The Governor shall appoint a member to
3 the Arkansas Towing and Recovery Board as provided under this act on or
4 before July 1, 2009, to replace the term of one (1) of the members who is not
5 associated with the towing industry and who is appointed under § 27-50-
6 1203(a)(2)(C).

7
8 SECTION 3. EMERGENCY CLAUSE. It is found and determined by the
9 General Assembly of the State of Arkansas that the Arkansas Towing and
10 Recovery Board serves an important and valuable role in this state; that the
11 board requires restructuring to fulfill its functions and advance its goals;
12 and that this act is immediately necessary because the ideal time to commence
13 this restructuring is on the expiration the term of another member and before
14 the beginning of the state's fiscal year. Therefore, an emergency is
15 declared to exist and this act being necessary for the preservation of the
16 public peace, health, and safety shall become effective on June 22, 2009.
