## For An Act To Be Entitled

9 AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL  
10 SERVICES AND OPERATING EXPENSES FOR THE  
11 DEPARTMENT OF FINANCE AND ADMINISTRATION - OFFICE  
12 OF CHILD SUPPORT ENFORCEMENT FOR THE FISCAL YEAR  
13 ENDING JUNE 30, 2011; AND FOR OTHER PURPOSES.

16 AN ACT FOR THE DEPARTMENT OF FINANCE AND  
17 ADMINISTRATION - OFFICE OF CHILD SUPPORT  
18 ENFORCEMENT APPROPRIATION FOR THE 2010-  
19 2011 FISCAL YEAR.

23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
24

25 SECTION 1. REGULAR SALARIES. There is hereby established for the  
26 Department of Finance and Administration - Office of Child Support  
27 Enforcement for the 2010-2011 fiscal year, the following maximum number of  
28 regular employees whose salaries shall be governed by the provisions of the  
29 Uniform Classification and Compensation Act (Arkansas Code §§21-5-201 et  
30 seq.), or its successor, and all laws amendatory thereto. Provided, however,  
31 that any position to which a specific maximum annual salary is set out herein  
32 in dollars, shall be exempt from the provisions of said Uniform  
33 Classification and Compensation Act. All persons occupying positions  
34 authorized herein are hereby governed by the provisions of the Regular  
35 Salaries Procedures and Restrictions Act (Arkansas Code §21-5-101), or its  
36 successor.

6 SECTION 2. EXTRA HELP. There is hereby authorized, for the Department of  
 7 Finance and Administration - Office of Child Support Enforcement for the  
 8 2010-2011 fiscal year, the following maximum number of part-time or temporary  
 9 employees, to be known as "Extra Help", payable from funds appropriated  
 10 herein for such purposes: fifteen (15) temporary or part-time employees,  
 11 when needed, at rates of pay not to exceed those provided in the Uniform  
 12 Classification and Compensation Act, or its successor, or this act for the  
 13 appropriate classification.

15 SECTION 3. APPROPRIATION - OPERATIONS. There is hereby appropriated, to  
 16 the Department of Finance and Administration - Office of Child Support  
 17 Enforcement, to be payable from the Child Support Enforcement Fund, for  
 18 personal services and operating expenses of the Department of Finance and  
 19 Administration - Office of Child Support Enforcement - Operations for the  
 20 fiscal year ending June 30, 2011, the following:

36 SECTION 4. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

1 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EXTRA  
 2 HELP EXEMPTION. Extra Help positions authorized herein are specifically  
 3 exempt from limitation of hours, either by act or regulation. Provided,  
 4 however, when a temporary or part-time employee is employed by the Department  
 5 of Finance and Administration - Office of Child Support Enforcement for a  
 6 period of time exceeding seven (7) months, a report of such shall be filed  
 7 with the Legislative Council.

8 The provisions of this section shall be in effect only from July 1,  
 9 ~~2007~~ 2010 through June 30, ~~2009~~ 2011.

10  
 11 SECTION 5. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized  
 12 by this act shall be limited to the appropriation for such agency and funds  
 13 made available by law for the support of such appropriations; and the  
 14 restrictions of the State Procurement Law, the General Accounting and  
 15 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
 16 Procedures and Restrictions Act, or their successors, and other fiscal  
 17 control laws of this State, where applicable, and regulations promulgated by  
 18 the Department of Finance and Administration, as authorized by law, shall be  
 19 strictly complied with in disbursement of said funds.

20  
 21 SECTION 6. LEGISLATIVE INTENT. It is the intent of the General Assembly  
 22 that any funds disbursed under the authority of the appropriations contained  
 23 in this act shall be in compliance with the stated reasons for which this act  
 24 was adopted, as evidenced by the Agency Requests, Executive Recommendations  
 25 and Legislative Recommendations contained in the budget manuals prepared by  
 26 the Department of Finance and Administration, letters, or summarized oral  
 27 testimony in the official minutes of the Arkansas Legislative Council or  
 28 Joint Budget Committee which relate to its passage and adoption.

29  
 30 SECTION 7. EMERGENCY CLAUSE. It is found and determined by the General  
 31 Assembly, that the Constitution of the State of Arkansas prohibits the  
 32 appropriation of funds for more than a one (1) year period; that the  
 33 effectiveness of this Act on July 1, 2010 is essential to the operation of  
 34 the agency for which the appropriations in this Act are provided, and that in  
 35 the event of an extension of the legislative session, the delay in the  
 36 effective date of this Act beyond July 1, 2010 could work irreparable harm

1 upon the proper administration and provision of essential governmental  
2 programs. Therefore, an emergency is hereby declared to exist and this Act  
3 being necessary for the immediate preservation of the public peace, health  
4 and safety shall be in full force and effect from and after July 1, 2010.
