22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
23

24 SECTION 1. REGULAR SALARIES. There is hereby established for the
25 Department of Education - Educational Television Division for the 2011-2012
26 fiscal year, the following maximum number of regular employees.

11 SECTION 2. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 12 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EXTRA
 13 HELP – STATE OPERATIONS. There is hereby authorized, for the Department of
 14 Education - Educational Television Division – State Operations for the ~~2010-~~
 15 ~~2011~~ 2011-2012 fiscal year, the following maximum number of part-time or
 16 temporary employees, to be known as "Extra Help", payable from funds
 17 appropriated herein for such purposes: five (5) temporary or part-time
 18 employees, when needed, at rates of pay not to exceed those provided in the
 19 Uniform Classification and Compensation Act, or its successor, for the
 20 appropriate classification. Many of these positions are related to specific
 21 projects, and those positions so related are specifically exempt from
 22 limitations of hours, either by act or regulation.

23 The provisions of this section shall be in effect only from July 1, ~~2010~~
 24 2011 through June 30, ~~2011~~ 2012.

26 SECTION 3. APPROPRIATION - STATE OPERATIONS. There is hereby
 27 appropriated, to the Department of Education - Educational Television
 28 Division, to be payable from the Educational Television Fund Account, for
 29 personal services and operating expenses of the Department of Education -
 30 Educational Television Division - State Operations for the fiscal year ending
 31 June 30, 2012, the following:

10 SECTION 4. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 11 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EXTRA
 12 HELP – CASH OPERATIONS. There is hereby authorized, for the Department of
 13 Education - Educational Television Division - Cash Operations for the ~~2010-~~
 14 ~~2011~~ 2011-2012 fiscal year, the following maximum number of part-time or
 15 temporary employees, to be known as "Extra Help", payable from funds
 16 appropriated herein for such purposes: forty-six (46) temporary or part-time
 17 employees, when needed, at rates of pay not to exceed those provided in the
 18 Uniform Classification and Compensation Act, or its successor, for the
 19 appropriate classification. Many of these positions are related to specific
 20 projects, and those positions so related are specifically exempt from
 21 limitations of hours, either by act or regulation.

22 The provisions of this section shall be in effect only from July 1, ~~2010~~
 23 2011 through June 30, ~~2011~~ 2012.

24

25 SECTION 5. APPROPRIATION - CASH OPERATIONS. There is hereby
 26 appropriated, to the Department of Education - Educational Television
 27 Division, to be payable from the cash fund deposited in the State Treasury as
 28 determined by the Chief Fiscal Officer of the State, for personal services
 29 and operating expenses of the Department of Education - Educational
 30 Television Division - Cash Operations for the fiscal year ending June 30,
 31 2012, the following:

11 SECTION 6. APPROPRIATION - HONORING ARKANSAS' WAR HEROES. There is
 12 hereby appropriated, to the Department of Education - Educational Television
 13 Division, to be payable from the Educational Television Fund Account, for
 14 personal services and operating expenses for the "Honoring Arkansas' War
 15 Heroes - Documenting Stories of Arkansas' World War II Veterans"
 16 documentation project of the Department of Education - Educational Television
 17 Division for the fiscal year ending June 30, 2012, the following:

23 SECTION 7. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 24 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. HONORING
 25 ARKANSAS' WAR HEROES. The appropriation authorized in this Act for Honoring
 26 Arkansas' War Heroes is not intended to be carried forward into the base
 27 level for the purposes of budget preparation. Any appropriation request for
 28 this purpose shall be considered a new appropriation request, and therefore
 29 will be considered a change level budget request.

30

31 Notwithstanding any law pertaining to the transfer of year-end fund
 32 balances or any law to the contrary, any funds provided to the Educational
 33 Television Fund Account for the purpose of funding the Honoring Arkansas' War
 34 Heroes Appropriation which remain in the Educational Television Fund Account
 35 at the end of a fiscal year shall remain in the Educational Television Fund
 36 Account and shall continue to be allocated to the Honoring Arkansas' War
 Heroes Appropriation in the following fiscal year.

1 SECTION 8. Item (A) of SECTION 8 of Act 73 of 2011 is amended to read
2 as follows:

3 (A) Effective July 1, 2011, the balance of the appropriation provided
4 in Item (A) Section 15 of Act 257 of 2010, for costs associated with the
5 planning for a Northwest Communications Center and implementing, equipping,
6 maintenance and operating expenses of an AETN satellite broadcasting site in
7 Northwest Arkansas, in a sum not to exceed\$99,904.

8
9 SECTION 9. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
10 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. As
11 referenced in SECTION 3 Subsection (c) of Act 1405 of 1999, the authorized
12 funding for the Dept. of Education - Educational Television Commission for NW
13 Communication Ctr/Digital Conversion/Transponder shall also be deemed to
14 include costs for implementing, equipping, maintenance and operating expenses
15 of an AETN satellite broadcasting site in Northwest Arkansas.

16
17 SECTION 10. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
18 authorized by this act shall be limited to the appropriation for such agency
19 and funds made available by law for the support of such appropriations; and
20 the restrictions of the State Procurement Law, the General Accounting and
21 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
22 Procedures and Restrictions Act, or their successors, and other fiscal
23 control laws of this State, where applicable, and regulations promulgated by
24 the Department of Finance and Administration, as authorized by law, shall be
25 strictly complied with in disbursement of said funds.

26
27 SECTION 11. LEGISLATIVE INTENT. It is the intent of the General
28 Assembly that any funds disbursed under the authority of the appropriations
29 contained in this act shall be in compliance with the stated reasons for
30 which this act was adopted, as evidenced by the Agency Requests, Executive
31 Recommendations and Legislative Recommendations contained in the budget
32 manuals prepared by the Department of Finance and Administration, letters, or
33 summarized oral testimony in the official minutes of the Arkansas Legislative
34 Council or Joint Budget Committee which relate to its passage and adoption.

35
36 SECTION 12. EMERGENCY CLAUSE. It is found and determined by the

1 General Assembly, that the Constitution of the State of Arkansas prohibits
2 the appropriation of funds for more than a one (1) year period; that the
3 effectiveness of this Act on July 1, 2011 is essential to the operation of
4 the agency for which the appropriations in this Act are provided, and that in
5 the event of an extension of the legislative session, the delay in the
6 effective date of this Act beyond July 1, 2011 could work irreparable harm
7 upon the proper administration and provision of essential governmental
8 programs. Therefore, an emergency is hereby declared to exist and this Act
9 being necessary for the immediate preservation of the public peace, health
10 and safety shall be in full force and effect from and after July 1, 2011.
