25	17-25-501. Pur	pose.

1	For purposes of this subchapter:
2	(1) "Committee" means the Residential Building Contractors
3	Committee created by this subchapter;
4	(2) "Home improvement contractor" means any person, firm,
5	partnership, co-partnership, association, corporation, or other organization
6	or any combination that attempts to or submits a bid, or contracts,
7	undertakes, or assumes charge in a supervisory capacity or otherwise manages
8	the reconstruction, alteration, renovation, repair, modification,
9	improvement, removal, demolition, or addition to any preexisting single
10	family residence or the property and structures appurtenant thereto;
11	$\frac{(2)}{(3)}$ "Residential building contractor" means any person, firm
12	partnership, copartnership, association, corporation, or other organization
13	or any combination thereof, which for a fixed price, commission, fee, or
14	wage, attempts to or submits a bid to construct or contract or undertakes to
15	construct or assumes charge in a supervisory capacity or otherwise manages
16	the construction of \underline{a} single family $\frac{1}{2}$ residence or the property and
17	structures appurtenant thereto; and
18	(3)(4) "Single family residence" means any project consisting of
19	one (1) but not more than four (4) units of new construction for residential
20	occupancy, when the cost of the project is twenty thousand dollars (\$20,000)
21	or more. This definition does not apply to subcontractors of licensed
22	residential building contractors or to remodeling operations.

24	SECTION 3. Arkansas Code § 17-25-503(a)(1), concerning the Residential
25	Contractors Committee, is amended to read as follows:
26	(a)(1) There is created the Residential Building Contractors
27	Committee, to consist of seven (7) members.
28	
29	SECTION 4. Arkansas Code § 17-25-504 is amended to read as follows:
30	17-25-504. Authority.
31	The Residential Building Contractors Committee may:
32	(1) Issue, modify, suspend, and revoke residential building
33	contractor's licenses issued by the committee;
34	(2) Establish qualifications for residential building
35	contractor's licenses issued by the committee;
36	(3) Enforce this subchanter and the committee's regulations

1	rules;
2	(4) Issue regulations rules necessary for the implementation of
3	this subchapter;
4	(5) Levy civil penalties in the same amounts and under the same
5	procedures as prescribed for the Contractors Licensing Board under this
6	subchapter;
7	(6) Issue orders of abatement in the same manner and to the same
8	extent as authorized for the board Contractors Licensing Board under § 17-25-
9	<u>103</u> ; and
10	(7) Seek any other civil remedies which are available to the

13	SECTION 5. Arkansas Code § 17-25-505 is amended to read as follows:
14	17-25-505. License from committee required.
15	(a) No $\underline{\mathtt{A}}$ person shall $\underline{\mathtt{not}}$ act as a residential building contractor
16	after July 1, 2001, unless licensed by the Residential Building Contractors
17	Committee or exempted from licensure under this subchapter.
18	(b) A person shall not act as a home improvement contractor after
19	January 1, 2012, unless:
20	(1) Licensed by the Residential Contractors Committee; or
21	(2) Exempt from licensure under this subchapter.
22	
23	SECTION 6. Arkansas Code § 17-25-506 is amended to read as follows:
24	17-25-506. Application for license.
25	(a) Applications for licensure shall be made on forms prescribed by
26	the Residential Building Contractors Committee and shall have attached
27	thereto:
28	(1) (A) A Except as provided in subdivision (a)(1)(B) of this
29	$\underline{\text{section, a}}$ compiled financial statement with each $\underline{\text{new}}$ application $\underline{\text{for all}}$
30	persons and entities required by this subchapter to be licensed by the
31	Residential Contractors Committee when the cost of the work done or to be
32	done in the State of Arkansas by the contractor, including without limitation
33	labor and materials, is twenty thousand dollars (\$20,000) or more.
34	(B) A person or entity required to be licensed under this
35	subchapter when the cost of the work done or to be done in the State of

Arkansas by the contractor, including without limitation labor and materials,

1	is less than twenty thousand dollars (\$20,000) shall not be required to
2	submit a financial statement; and
3	(2) Such other information as required by the committee.
4	(b)(1) The financial statement required with each application is not
5	public information and may not be made available for inspection by any
6	person, unless by an order of a court of competent jurisdiction.
7	(2) After the contractor is licensed, the Contractors Licensing
8	Board shall destroy the financial statement by the process of shredding or
9	returning the financial statement to the contractor.

11	SECTION 7. Arkansas Code § 17-25-507 is amended to read as follows:
12	17-25-507. Applicant qualifications.
13	(a) In determining the qualifications of any applicant for original
14	license or any renewal license, the Residential Building Contractors
15	Committee shall consider, among other things, the following:
16	(1) Experience;
17	(2) Ability;
18	(3) The manner of performance of previous contracts;
19	(4) Financial condition;
20	(5) Any other fact tending to show ability and willingness to
21	conserve the public health and safety; and
22	(6) Default in complying with the provisions of this subchapter
23	or any other law of the state.
24	(b) The committee may limit a license issued by the committee to the
25	character of work for which the applicant is qualified to perform.
26	
27	SECTION 8. Arkansas Code § 17-25-508 is amended to read as follows:
28	17-25-508. Name of licensed contractor.
29	Residential building contractors Contractors licensed under this
30	subchapter may act as such only in the name under which they are licensed by
31	the Residential Building Contractors Committee.

33	SECTION 9. Arkansas Code § 17-25-509 is amended to read as follows:
34	17-25-509. Written examination.
35	(a) Except as otherwise provided in this section, $rac{a}{no}$ person shall

 $\underline{\text{not}}$ be licensed as a residential building contractor unless the person has

1	passed a written examination prescribed by the Residential Building
2	Contractors Committee.
3	(b) Persons licensed by the Contractors Licensing Board shall not be
4	required to submit to written examination by the committee but must meet all
5	other requirements for licensure as a residential building contractor.
6	(c) A property owner who acts as a residential building contractor for
7	the purpose of constructing his or her own residence is not required to be
8	licensed under this subchapter unless the person constructs more than one (1)
9	residence per calendar year.
10	(b)(1) Until January 1, 2012, the committee shall waive the written
11	examination for a person who:
12	(A) Submits proof of having obtained five (5) building
13	permits within the three (3) years preceding the date of application;
14	(B) Submits proof of having obtained one (1) building
15	permit within the preceding twelve (12) months; or
16	(C) Submits proof of experience in construction acceptable
17	to the committee.
18	(2) Subsection (b)(1) of this section does not apply to
19	applicants for a residential builder license.
20	
21	SECTION 10. Arkansas Code § 17-25-510 is amended to read as follows:
22	17-25-510. Hearings regarding violations.
23	(a) The Residential Building Contractors Committee may conduct
24	hearings regarding alleged violations of this subchapter or regulations
25	promulgated thereunder, and the hearings shall be conducted in accordance
26	with the Arkansas Administrative Procedure Act, § 25-15-201 et seq. The
27	committee shall within a reasonable time make findings and determinations as
28	a result of the hearings.
29	(b) A contractor who, after notice and hearing, is found to have
30	committed the following actions shall pay to the Contractors Licensing Board
31	a civil penalty of not less than one hundred dollars (\$100) nor more than
32	four hundred dollars (\$400) for each day that the violation occurred:
33	(1) Acting as a contractor without having a valid license in
34	violation of this chapter;
35	(2) Using a contractor in violation of this chapter;
36	(3) Presenting or filing the license certificate of another;

1	(4) Giving false or forged evidence of any kind to the board in
2	obtaining a certificate of license;
3	(5) Using an expired or revoked certificate of license;
4	(6) Giving false or fraudulent evidence of a contractor's
5	license to another person or entity; or
6	(7) Committing other violations under this chapter.
7	(c) The committee may revoke the certificate of license of any
8	contractor licensed under this subchapter who is found guilty of:
9	(1) Fraud or deceit in obtaining a license;
10	(2) Aiding or abetting a contractor or person to violate this
11	chapter; or
12	(3) Gross negligence, incompetence, or misconduct in the
13	contractor's business.
14	
15	SECTION 11. Arkansas Code § 17-25-511 is amended to read as follows:
16	17-25-511. Appeal from committee decision.
17	Any person aggrieved by an action or decision of the Residential
18	Building Contractors Committee may appeal to the Contractors Licensing Board
19	within ten (10) calendar days after the action or decision under procedures
20	prescribed by the board. Aggrieved parties shall be granted an opportunity to
21	address the board regarding the committee's actions, and the final actions of
22	the board shall be binding upon the committee.
23	
24	SECTION 12. Arkansas Code § 17-25-512 is amended to read as follows:
25	17-25-512. Expiration of license Fees.
26	All licenses issued by the Contractors Licensing Board shall expire one
27	(1) year after the date of issuance unless otherwise provided by the
28	Residential Building Contractors Committee. The committee may charge
29	reasonable examination fees and delinquency fees and may charge a fee not to
30	exceed one hundred dollars (\$100) for new licenses or renewal of a license.
31	All fees and other moneys collected by the committee shall be disposed of as
32	provided by § 17-25-205 and shall be used by the board to implement this
33	subchapter.
34	
35	SECTION 13. Arkansas Code § 17-25-513 is amended to read as follows:

17-25-513. Exemption for personal homebuilder Exemptions.

1	Nothing in this subchapter shall be construed as requiring a person who
2	acts as a residential building contractor in the construction of his or her
3	own residence to obtain a license from the Residential Building Contractors
4	Committee unless the person builds more than one (1) residence during any
5	year.
6	The following shall be exempted from the licensing requirements of this
7	subchapter:
8	(1) A person who acts as a residential building contractor in
9	the construction of his or her residence unless he or she builds more than
10	one (1) residence during any calendar year;
11	(2) The owner of a single family residence acting as his or her
12	own home improvement contractor on his or her own property;
13	(3)(A) A person or entity acting as a residential building
14	contractor or a home improvement contactor on any project, when the cost of
15	the work done or to be done does not exceed two thousand dollars (\$2,000).
16	(B) Subdivision (3)(A) of this section shall not apply to
17	a project in which the construction work necessary to complete the project is
18	divided into separate contracts of amounts less than two thousand dollars
19	<i>(\$2,000)</i> ;
20	(4) A subcontractor of a contractor licensed by the Residential
21	Contractors Committee; and
22	(5) A person or entity licensed as a contractor by another
23	licensing agency, board, or commission of the State of Arkansas if the
24	contractor is performing work within the scope of the license held by the
25	person or entity.
26	
27	SECTION 14. Arkansas Code 17-25-514 is amended to read as follows:
28	17-25-514. Workers' compensation required.
29	(a) A residential building contractor required to be licensed by the
30	Residential Building Contractors Committee as a residential building
31	<pre>contractor shall secure the payment of workers' compensation under § 11-9-</pre>
32	401 et seq.
33	(b) The committee shall require proof of current workers' compensation
34	coverage before issuing or renewing a license as a residential building
35	contractor.
36	(c) Unless otherwise required by law, a home improvement contractor

1	required to be licensed under this subchapter shall not be required to secure
2	the payment of workers' compensation under § 11-9-401 et seq. or provide
3	proof of coverage to the committee before issuing or receiving a license if
4	the cost of the work done or to be done in the State of Arkansas by the home
5	improvement contractor, including without limitation labor and materials, is
6	less than twenty thousand dollars (\$20,000).
7	$\frac{(c)}{(d)}(1)$ If a contractor fails to maintain workers' compensation
8	coverage or fails to maintain proof of current workers' compensation coverage
9	on file with the committee, the committee shall revoke the contractor's
10	license.
11	(2) A contractor's license that has been revoked due to failure
12	to maintain workers' compensation coverage may be reinstated upon receipt of
13	proof that the contractor has secured workers' compensation coverage.
14	$\frac{(d)}{(e)}$ The committee shall promulgate rules necessary to enforce this
15	section.
16	
17	SECTION 15. Arkansas Code Title 17, Chapter 25, Subchapter 5 is
18	amended to add a new section to read as follows:
19	17-25-515. Actions to enforce contracts in violation of this
20	subchapter.
21	A contractor found guilty of a violation of this subchapter shall not
22	bring an action:
23	(1) In law or equity to enforce any provision of a contract
24	entered into in violation of this subchapter; or
25	(2) For quantum meruit.
