9 AN ACT TO MAKE VARIOUS CORRECTIONS TO TITLE 10 OF THE  
10 ARKANSAS CODE OF 1987 CONCERNING THE ARKANSAS STATE  
11 CLAIMS COMMISSION; AND FOR OTHER PURPOSES.

## Subtitle

15 TO MAKE VARIOUS CORRECTIONS TO TITLE 10  
16 OF THE ARKANSAS CODE OF 1987 CONCERNING  
17 THE ARKANSAS STATE CLAIMS COMMISSION.

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
21

22 SECTION 1. Arkansas Code § 10-3-314 is amended to read as follows to  
23 correct the dollar amount of the claim threshold to make the section  
24 consistent with the dollar amount listed in § 19-10-212, to correct agency  
25 names, and to make stylistic changes:

26 10-3-314. Report on claim filed with Arkansas State Claims Commission.

27 (a)(1) Except as provided by subsection (b) of this section, it is the  
28 intent of the General Assembly that when any state agency, board, commission,  
29 or institution of higher education admits liability to a claim filed with the  
30 Arkansas State Claims Commission and the claim involves a contract with a  
31 state agency, board, commission, or institution of higher education or the  
32 claim exceeds ~~seven thousand five hundred dollars (\$7,500)~~ ten thousand  
33 dollars (\$10,000) that ~~such the~~ the agency, board, commission, or institution of  
34 higher education file a written report ~~thereof~~ of the claim with the  
35 Litigation Reports Oversight Subcommittee of the Legislative Council.

36 (2) The report shall include a concise statement of facts with



1 an explanation of the agency's liability.

2 ~~(3) Provided further, such~~ The report shall be filed with the  
3 ~~litigation subcommittee~~ Litigation Reports Oversight Subcommittee of the  
4 Legislative Council within thirty (30) days after the claim has been  
5 adjudicated by the Arkansas State Claims Commission.

6 (b) The Arkansas Lottery Commission shall file its written report  
7 under subsection (a) of this section with the Arkansas Lottery Commission  
8 Legislative Oversight Committee.

9  
10 SECTION 2. DO NOT CODIFY. The enactment and adoption of this act  
11 shall not repeal, expressly or impliedly, the acts passed at the regular  
12 session of the Eighty-Eighth General Assembly. All such acts shall have the  
13 full force and effect and, so far as those acts intentionally vary from or  
14 conflict with any provision contained in this act, those acts shall have the  
15 effect of subsequent acts and as amending or repealing the appropriate parts  
16 of the Arkansas Code of 1987.
