19	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21	SECTION 1. Arkansas Code Ann. § 27-24-1301 is amended to read as	
22	follows:	
23	27-24-1301. Purpose.	
24	The purpose of this section subchapter is to:	
25	(1) Continue the special license plates for the certain public se	ervice
26	employees or public service retirees that existed before April 13, 2005	, and
27	to establish a procedure for other public service employees or retirees	to
28	obtain special license plates; and	
29	(2) Honor the service of Cold War veterans by providing a special	1
30	license plate that is available for issuance; and	
31	(3) Honor those individuals who served in the armed forces, but	<u>did</u>
32	not serve during a conflict or long enough to retire, by providing a spe	<u>ecial</u>
33	license plate that is available for issuance.

35	SECTION 2. Arkansas Code Title 27, Chapter 24, Subchapter 13 is	
36	amended to add an additional section to read as follows:	

1	27-24-1313. U.S. Veterans.
2	(a) The Department of Finance and Administration shall create for
3	issuance a special license plate that bears a decal stating "U.S. Veteran" to
4	be issued to an eligible applicant who establishes that he or she has served
5	in the:
6	(1) United States Army;
7	(2) United States Navy;
8	(3) United States Marine Corps;
9	(4) United States Air Force;
10	(5) United States Coast Guard;
11	(6) Army National Guard; or
12	(7) Air National Guard.
13	(b)(1) The special license plate shall be of the same basic design as
14	military service and veterans special license plates issued under § 27-24-
15	209, except that in lieu of the legend "The Natural State" at the bottom of
16	the special license plate, the plate shall bear a decal stating "U.S.
17	<u>Veteran".</u>
18	(2) The special license plate shall include a decal showing the
19	veteran's branch of service.
20	(c)(1) A United States veteran may apply for and annually renew a
21	special license plate issued under this section.
22	(2) The initial application and registration fee for the license
23	plate created under this section is the full fee amount as specified in § 27-
24	<u>14-601(a).</u>
25	(3) The fee for the renewal of a special license plate under
26	this section is the amount specified in § 27-14-601(a).
27	(4) The replacement fee for a special license plate issued under
28	this section is five dollars (\$5.00).
29	(d) Upon the initial application for a special license plate issued
30	under this section, the United States Veteran shall provide adequate proof to
31	the department that he or she is a United States Veteran.
32	(e) The special license plate created under this section may be used
33	only on a motor vehicle as defined and classified in § 27-24-103.
34	(f) The registration of a special license plate under this section
35	may:

(1) Continue from year to year as long as it is renewed each
