SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 23 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EDUCATIONAL TRAINING/RETRAINING. Of the funds and appropriation authorized by 24 25 Item (01) in the section of this Act for Adult Basic and General Adult 26 Education, a sum of \$300,000 each fiscal year shall be made available to 27 eligible entities approved by the State Board of Career Education, in order 28 to expand the vocational education and training opportunities available to 29 area citizens in need of adult educational training or retraining due to 30 changing technology. 31 Further, if the appropriation is not fully funded due to a decrease in 32 the official revenue forecast or the available carryover balance of the 33 Department of Workforce Education Public School Fund Account, the Department 34 of Career Education may reduce proportionally the amount made available to 35 eligible entities approved by the State Board of Career Education in order to 36 expand the vocational education and training opportunities to area citizens

- SECTION 23. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ADULT EDUCATION DISTRIBUTION. All funds that become available for Adult Education shall be distributed to those administrative units determined to be operating efficient and effective adult education programs, under criteria established by the State Board of Career Education. The criteria shall include the relative efficiency of administration of the program in the counties served and achievement of federal performance indicators. The State Board of Career Education shall promulgate rules and regulations for the distribution of funds in accordance with criteria to be determined by the Board. In the distribution of funds to local units the Board shall consider performance in
- meeting state and federal performance indicators. Unallocated funds will be redistributed based upon need as determined by the State Board of Career Education.

 The provisions of this section shall be in effect only from July 1,

SECTION 24. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER OF FUNDS — PROMOTIONAL ITEMS. The Chief Fiscal Officer of the State shall establish, upon request from the Department of Career Education, a special appropriation line item to be used in the acquisition of promotional items. When the Department of Career Education wishes to transfer monies from its operating expenses appropriation to the Promotional Items line, the State Board of Career Education shall approve the request and forward it after receiving prior review and approval by the Arkansas Legislative Council or Joint Budget Committee, to the Chief Fiscal Officer of the State for processing.

Determining the maximum number of employees and the maximum amount of appropriation and general revenue funding for a state agency each fiscal year is the prerogative of the General Assembly. This is usually accomplished by

- l delineating such maximums in the appropriation act(s) for a state agency and
- 2 the general revenue allocations authorized for each fund and fund account by
- 3 amendment to the Revenue Stabilization law. Further, the General Assembly
- 4 has determined that the Department of Career Education may operate more
- 5 efficiently if some flexibility is provided to the Department of Career
- 6 Education authorizing broad powers under this Section. Therefore, it is both
- 7 necessary and appropriate that the General Assembly maintain oversight by
- 8 requiring prior approval of the Legislative Council or Joint Budget Committee
- 9 as provided by this section. The requirement of approval by the Legislative
- 10 Council or Joint Budget Committee is not a severable part of this section.
- 11 If the requirement of approval by the Legislative Council or Joint Budget
- 12 Committee is ruled unconstitutional by a court of competent jurisdiction,
- 13 this entire section is void.

- 15 SECTION 25. SPECIAL LANGUAGE NOT TO BE INCORPORATED INTO THE ARKANSAS
 16 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SECONDARY
 17 TECHNICAL CENTER AID PROVISIONS.
 - (a)(1) Secondary technical center aid shall be calculated and distributed by the Department of Career Education based upon each secondary technical center's eligible student full-time equivalent count.
 - (2) Secondary technical center aid shall not be based upon the percentage of total enrollment from any one sending school.
 - (b) This section expires on June 30, 2013.

SECTION 26. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and the restrictions of the State Procurement Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of said funds.

SECTION 27. LEGISLATIVE INTENT. It is the intent of the General
Assembly that any funds disbursed under the authority of the appropriations
contained in this act shall be in compliance with the stated reasons for

1	which this act was adopted, as evidenced by the Agency Requests, Executive
2	Recommendations and Legislative Recommendations contained in the budget
3	manuals prepared by the Department of Finance and Administration, letters, or
4	summarized oral testimony in the official minutes of the Arkansas Legislative
5	Council or Joint Budget Committee which relate to its passage and adoption.

7	SECTION 28. EMERGENCY CLAUSE. It is found and determined by the
8	General Assembly, that the Constitution of the State of Arkansas prohibits
9	the appropriation of funds for more than one (1) year period; that the
10	effectiveness of this Act on July 1, 2012 is essential to the operation of
11	the agency for which the appropriations in this Act are provided; with the
12	exception that SECTION 25 in this Act shall be in full force and effect from
13	and after the date of its passage and approval, and that in the event of an
14	extension of the legislative session, the delay in the effective date of this
15	Act beyond July 1, 2012, could work irreparable harm upon the proper
16	administration and provision of essential governmental programs, with the
17	exception that SECTION 25 in this Act shall be in full force and effect from
18	and after the date of its passage and approval. Therefore, an emergency is
19	hereby declared to exist and this Act being necessary for the immediate
20	preservation of the public peace, health, and safety shall be in full force
21	and effect from and after July 1, 2012; with the exception that SECTION 25 in
22	this Act shall be in full force and effect from and after the date of its
23	passage and approval.
