6 SECTION 7. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 7 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SPECIAL 8 ALLOWANCES. For the purpose of providing necessary allowances for housing 9 and other unusual expenses incurred by or in behalf of the athletic director, 10 assistant athletic directors, head coaches, and assistant coaches at the 11 University of Arkansas at Little Rock, the Board of Trustees may make special allowances available therefor in such amounts as the Board of Trustees may 12 13 determine as justified, an equitable allowance in view of the unusual and 14 exacting duties of said athletic director, assistant athletic directors, head 15 coaches, and assistant coaches, and for the purpose of providing such 16 allowances, the Board of Trustees is authorized to expend from the auxiliary 17 income of the University of Arkansas at Little Rock, which is derived from 18 athletic event receipts, an amount not to exceed twenty thousand dollars 19 (\$20,000) in the aggregate for such purposes during each fiscal year for the 20 athletic director and head coaches, and ten thousand dollars (\$10,000) in the 21 aggregate for such purposes during each fiscal year for the assistant 22 athletic directors and assistant coaches. Provided that any such allowances 23 shall be in addition to the regular salary of such athletic director, 24 assistant athletic directors, head coaches and assistant coaches, as 25 established herein provided that the amount of such allowance shall not 26 exceed ten thousand dollars (\$10,000) per annum for any one salaried 27 position. Further, if the special allowance funds authorized herein are 28 utilized the University of Arkansas at Little Rock shall report annually to 29 the Legislative Joint Auditing Committee the exact disposition of those 30 special allowances funds.

The provisions of this section shall be in effect only from July 1, 2012
2013 through June 30, 2013 2014.

34 SECTION 8. COMPLIANCE WITH OTHER LAWS. Disbursement of funds 35 authorized by this act shall be limited to the appropriation for such agency 36 and funds made available by law for the support of such appropriations; and

the restrictions of the State Procurement Law, the General Accounting and
 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
 Procedures and Restrictions Act, the Higher Education Expenditures
 Restrictions Act, or their successors, and other fiscal control laws of this
 State, where applicable, and regulations promulgated by the Department of
 Finance and Administration, as authorized by law, shall be strictly complied
 with in disbursement of said funds.

9 SECTION 9. LEGISLATIVE INTENT. It is the intent of the General 10 Assembly that any funds disbursed under the authority of the appropriations 11 contained in this act shall be in compliance with the stated reasons for 12 which this act was adopted, as evidenced by the Agency Requests, Executive 13 Recommendations and Legislative Recommendations contained in the budget 14 manuals prepared by the Department of Finance and Administration, letters, or 15 summarized oral testimony in the official minutes of the Arkansas Legislative 16 Council or Joint Budget Committee which relate to its passage and adoption. 17

18 SECTION 10. EMERGENCY CLAUSE. It is found and determined by the 19 General Assembly, that the Constitution of the State of Arkansas prohibits 20 the appropriation of funds for more than a one (1) year period; that the effectiveness of this Act on July 1, 2013 is essential to the operation of 21 22 the agency for which the appropriations in this Act are provided, and that in 23 the event of an extension of the legislative session, the delay in the effective date of this Act beyond July 1, 2013 could work irreparable harm 24 25 upon the proper administration and provision of essential governmental 26 programs. Therefore, an emergency is hereby declared to exist and this Act 27 being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 2013. 28 29 30 /s/Joint Budget Committee 31 32
