20	SECTION 1. Arkansas Code Title 5, Chapter 73, Subchapter 1, is amen	ıded
21	to add a new section to read as follows:	
22	5-73-111. Unlawful procurement of a firearm.	
23	(a) As used in this section:	
24	(1) "Ammunition" means any cartridge, shell, or projectile	
25	designed for use in a firearm;	
26	(2) "False information" means information that portrays an	
27	unlawful transaction as lawful or a lawful transaction as unlawful;	
28	(3) "Licensed dealer" means a person who is licensed under 18	<u>3</u>
29	U.S.C. § 923, as it existed on January 1, 2013, to engage in the business	of
30	dealing in firearms; and	
31	(4) "Private seller" means a person other than a licensed dea	<u>ller</u>
32	who sells or offers for sale a firearm or ammunition.	
33	(b) A person commits the offense of unlawful procurement of a firea	<u>ırm</u>
34	or ammunition if he or she knowingly:	
35	(1) Solicits, persuades, encourages, or entices a licensed	
36	dealer or private seller to transfer a firearm or ammunition under unlawfu	<u>11</u>

1	circumstances; or
2	(2) Provides false information to a licensed dealer or private
3	seller with a purpose to deceive the licensed dealer or private seller
4	concerning the lawfulness of a transfer of a firearm or ammunition.
5	(c) It is a defense to prosecution under this section if the person
6	<u>is:</u>
7	(1) A law enforcement officer acting in his or her official
8	capacity; or
9	(2) Acting at the direction of a law enforcement officer.
10	(d) Unlawful procurement of a firearm or ammunition is a Class D
11	felony.
