25	for officers prescribed by the Arkansas Constitution.		
26	(f)(1) Whenever a vacancy occurs in the membership of the state board $_{f  au}$		
27	the Governor:		
28	(A) If the vacancy is for an appointed position, the		
29	officer who made the original appointment shall appoint a successor who shall		
30	serve the remainder of the unexpired term of the member that he or she		
31	succeeded, subject to all other provisions of this section; and		
32	(B) If the vacancy is for an elected position, the		
33	Governor shall appoint a successor who shall serve the remainder of the		
34	unexpired term.		
35	(2) Resignation, removal from the district from position to
