19	(a) Any certified law enforcement officer <u>,</u> <del>or</del> auxiliary law		
20	enforcement officer acting as an auxiliary law enforcement officer <u>, or</u>		
21	employee of a local detention facility may carry a concealed handgun if that		
22	officer <u>or employee</u> :		
23	(1) Is presently in the employ of a public law enforcement		
24	department, office, or agency;		
25	(2) Is authorized by the public law enforcement department,		
26	office, or agency to carry a firearm in the course and scope of his or her		
27	duties;		
28	(3) Is not subject to any disciplinary action that suspends his		
29	or her authority as a law enforcement officer <u>or employee of a local</u>		
30	detention facility by the public law enforcement department, office, or		
31	agency;		
32	(4) Is carrying a badge and appropriate written photographic		
33	identification issued by the public law enforcement department, office, or		
34	agency identifying him or her as a certified law enforcement officer <u>or</u>		
35	employee of a local detention facility;		
36	(5) Is not otherwise prohibited under federal law;
