21	SECTION 1. Arkansas Code Title 20, Chapter 77, Subchapter 1, is
22	amended to add an additional section to read as follows:
23	20-77-125. Medicaid Provider Tax Returns.
24	(a) As used in this section, "Affected Medicaid Entity" means an
25	<u>individual or entity that:</u>
26	(1) Provides and is directly reimbursed by Medicaid for services
27	<u>in the Arkansas Medicaid Program;</u>
28	(2) Is required to submit an annual financial audit to the
29	<u>Department of Human Services; and</u>
30	(3) Is required to file a state income tax return, state
31	<u>withholding tax return, pass-through entity withholding tax return, or a</u>
32	<u>composite pass-through entity tax return or pay any tax due for the previous</u>
33	<u>calendar year.</u>
34	(b)(1) On or before December 1 of each year, the Department of Human
35	Services shall provide the Department of Finance and Administration with a
