SECTION 9. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 5 6 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. YOUTH 7 SERVICES - COMMUNITY-BASED RESIDENTIAL PROGRAMS - RESTRICTIONS. The 8 Department of Human Services shall not contract or pay for community-based 9 residential programs within any municipality to house unrelated persons who 10 have been adjudicated delinquent of an act that would constitute a Class A 11 felony or higher or of a sexual offense or convicted of a Class A felony or 12 higher or sexual offense until the following conditions have been met: 13 1. Residents within one thousand (1,000) feet of the proposed location of 14 the facility shall be notified by mail;

15 2. A public hearing shall be conducted in the community of the proposed 16 location of the facility by the contract provider at least ten (10) days in 17 advance of the contract's effective date. Notice of the hearing shall be made 18 by mail to each of the residents within 1,000 feet of the proposed location 19 of the facility. The notification requirement shall not apply to already 20 existing facilities at already existing locations.

Provided further, upon establishment of such facilities within a particular municipality, the contract provider and the Department shall establish and implement a system to receive and respond to complaints and questions from residents of such municipality. In the event the Department and the provider fail to provide satisfactory communication as provided in this section to the residents, such facility may be declared a public nuisance by the municipality.

SECTION 10. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER OF FUNDS FOR THE JUVENILE OMBUDSMAN PROGRAM. The Department of Human Services shall provide funding in an amount not to exceed \$240,000 for the fiscal year ending June 30, <u>2013</u> <u>2014</u> for the Juvenile Ombudsman Program described in ACA 16-87-216. Upon request by the Executive Director of the

Arkansas Public Defender Commission, the Chief Fiscal Officer of the State
 shall transfer an amount not to exceed \$240,000 for the fiscal year ending
 June 30, <u>2013</u> <u>2014</u> from an account designated by the Director of the
 Department of Human Services to the State Central Services Fund as a direct

7 SECTION 11. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 8 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER 9 OF FUNDS FOR LOCAL JUVENILE DETENTION FACILITIES. The Chief Fiscal Officer of the State shall transfer funds in an amount of \$400,000 for the fiscal 10 11 year ending June 30, 2013 2014 from the Department of Human Services - Youth 12 Services Fund Account to the Juvenile Detention Facilities Operating Fund to 13 fund the appropriation to the Department of Finance and Administration -14 Disbursing Officer for grants for operating expenses of local juvenile 15 detention facilities.

YOUTH SERVICES - TIMBER SALES PROCEEDS - CAPITAL IMPROVEMENTS AND EQUIPMENT. 24 The 25 Division of Youth Services is authorized to use the administrative operating 26 account for capital improvements to the physical plant and for the purchase 27 of capital equipment by the Mansfield Youth Services Facility operated by the 28 Department of Human Services, Division of Youth Services. The funds shall be 29 held by the Department of Human Services, Division of Youth Services from the proceeds of the sale of timber that may be harvested from land owned by the 30 31 Division of Youth Services. All funds deposited and all expenses shall be 32 tracked separately. The harvesting of timber is specifically authorized to 33 provide funds to finance capital improvements to the physical plant and for 34 the purchase of major capital equipment by the Mansfield Facility from which 35 the timber is sold.

36 The Division of Youth Services shall report all income derived from the

1 sale of timber to the Chief Fiscal Officer of the State and the Arkansas 2 Legislative Council. Any contracts initiated for the harvesting and sale of 3 timber shall be submitted to the Review Subcommittee of the Arkansas 4 Legislative Council for prior review. All expenditures of funds derived from 5 the sale of timber will be expended in accordance with relevant state 6 purchasing laws.

7 The provisions of this section shall be in effect only from July 1, $\frac{2012}{2012}$ 8 2013 through June 30, 2013 2014.

SECTION 13. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 10 11 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. REGULAR 12 SALARIES - CONTINGENT EDUCATIONAL SERVICES POSITIONS. If it has been determined by the Director of the Department of Human Services that the 13 14 Division of Youth Services cannot continue a contract with a private provider 15 for educational services and deems it necessary to utilize Division staff to 16 provide the required educational services, the Division is authorized, to 17 seek the approval of the Chief Fiscal Officer of the State, the Governor and 18 the Arkansas Legislative Council or Joint Budget Committee, to utilize the 19 contingent educational services positions contained in this Act and to make 20 the appropriate transfers from the Residential Services Appropriation line 21 item contained in this Act to Regular Salaries, Personal Services Matching, 22 and various Maintenance and General Operations classifications.

23 There is hereby established for the Division of Youth Services -24 Contingent Educational Services Positions for the 2012-2013 2013-2014 fiscal 25 year, the following maximum number of regular employees whose salaries shall 26 be governed by the provisions of the Uniform Classification and Compensation 27 Act (Arkansas Code 21-5-201 et seq.), or its successor, and all laws 28 amendatory thereto. Provided, however, that any position to which a specific 29 maximum annual salary is set out herein in dollars, shall be exempt from the 30 provisions of said Uniform Classification and Compensation Act. 5	effective date of this Act beyond July 1, 2013 could work irreparable harm
6	upon the proper administration and provision of essential governmental
7	programs. Therefore, an emergency is hereby declared to exist and this Act
8	being necessary for the immediate preservation of the public peace, health
9	and safety shall be in full force and effect from and after July 1, 2013.
