DO NOT CODIFY. The enactment and adoption of this act 32 shall not repeal, expressly or impliedly, the acts passed at the regular 33 session of the Eighty-Ninth General Assembly. All such acts shall have the 34 full force and effect and, so far as those acts intentionally vary from or conflict with any provision contained in this act, those acts shall have the 35 36 effect of subsequent acts and as amending or repealing the appropriate parts
