24	SECTION 1. APPR	OPRIATION - LEDBETTER BUILDING AND RAG	LAND BUILDING.	
25	There is hereby appropriated, to the Department of Finance and Administration			
26	- Revenue Services Division, to be payable from the General Improvement Fund			
27	or its successor fund or fund accounts, the following:

29	Ragland Building, in	a sum not to exceed	\$858,188.

31	SECTION 2. DISB	URSEMENT CONTROLS. (A) No contract mag	y be awarded nor	
32	obligations otherwise incurred in relation to the project or projects			
33	described herein in excess of the State Treasury funds actually available			
34	therefor as provided by law. Provided, however, that institutions and			
35	agencies listed herein shall have the authority to accept and use grants and			
36	donations including F	ederal funds, and to use its unobligate	ed cash income or	

- 1 funds, or both available to it, for the purpose of supplementing the State
- 2 Treasury funds for financing the entire costs of the project or projects
- enumerated herein. Provided further, that the appropriations and funds 3
- 4 otherwise provided by the General Assembly for Maintenance and General
- 5 Operations of the agency or institutions receiving appropriation herein shall
- 6 not be used for any of the purposes as appropriated in this act.
- 7 (B) The restrictions of any applicable provisions of the State Purchasing
- 8 Law, the General Accounting and Budgetary Procedures Law, the Revenue
- 9 Stabilization Law and any other applicable fiscal control laws of this State
- and regulations promulgated by the Department of Finance and Administration, 10

SECTION 3. LEGISLATIVE INTENT. It is the intent of the General 14 15 Assembly that any funds disbursed under the authority of the appropriations 16 contained in this act shall be in compliance with the stated reasons for 17 which this act was adopted, as evidenced by the Agency Requests, Executive 18 Recommendations and Legislative Recommendations contained in the budget 19

manuals prepared by the Department of Finance and Administration, letters, or 20

summarized oral testimony in the official minutes of the Arkansas Legislative

21 Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a one (1) year period; that the effectiveness of this Act on July 1, 2013 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the legislative session, the delay in the effective date of this Act beyond July 1, 2013 could work irreparable harm

upon the proper administration and provision of essential governmental

programs. Therefore, an emergency is hereby declared to exist and this Act 31

32 being necessary for the immediate preservation of the public peace, health

33 and safety shall be in full force and effect from and after July 1, 2013.
