23	BE IT ENACTED BY THE	GENERAL ASSEMBLY OF THE STATE OF ARKA	NSAS:

25	SECTION 1. Ark	ansas Code § 7-4-101(a)-(e), concerni	ng composition and
26	terms of the State Bo	oard of Election Commissioners, is ame	nded to read as
27	follows:		
28	(a) The State	Board of Election Commissioners shall	be composed of the
29	following seven $(7)$ nine $(9)$ persons, with at least one $(1)$ from each		
30	congressional distric

14	(9) One (1) person designated by the Lieutenant Governor.	
15	(b) The Secretary of State shall serve as chair and secretary of the	
16	board.	
17	(c) Except for the Secretary of State and the county clerk, no member	
18	of the board shall be an elected public official.	
19	(d)(1) $\underline{(A)}$ The term on the board of the Secretary of State shall be	
20	concurrent with his or her term in office.	
21	(2) The county clerk shall hold the office of county clerk when	
22	appointed to the board and shall be removed as a member of the board if not	
23	in office.	
24	(B) Members of the board appointed by the chairs of the	
25	parties shall be appointed for terms of four (4) years and shall continue to	
26	serve until their successors have been appointed and taken the official oath.	
27	(3)(A)(C) Members of the board appointed by the President Pro	
28	Tempore of the Senate and the Speaker of the House of Representatives shall	
29	be appointed for terms of two (2) years and shall continue to serve until	
30	successors have been appointed and taken the official oath.	
31	(B) All other appointive members shall be appointed for	
32	terms of four (4) years and shall continue to serve until successors have	
33	been appointed and taken the official oath.	
34	(D) A member of the board appointed by the Governor shall	
35	serve at the pleasure of the Governor.	
36	(E) A member of the board appointed by the Lieutenant

- 1 Governor shall serve at the pleasure of the Lieutenant Governor.
- 2  $\frac{(4)(2)}{(4)}$  No appointive member shall be appointed to serve more
- 3 than two (2) consecutive full terms.
- 4  $\frac{(5)(A)(3)(A)}{(5)(5)(5)}$  If a vacancy on the board occurs, a successor shall
- 5 be appointed within thirty (30) days to serve the remainder of the unexpired
- 6 term.
- 7 (B) The appointment shall be made by the official holding
- 8 the office responsible for appointing the predecessor.
- 9 (e)(1) The board shall meet as needed upon call of the chair or upon
- 10 written request to the chair of any four (4) members.
- 11 (2) A majority of the membership of the board shall constitute a
- 12 quorum for conducting business.
- 13 (3) No sanctions shall be imposed without the affirmative vote
- of at least four (4) five (5) members of the board.
- 15 (4) Meetings of the board may be chaired and conducted by either
- 16 the chair or a member of the board designated by the chair as acting chair
- 17 for the meeting.

- 19 SECTION 2. <u>DO NOT CODIFY.</u>
- 20 Effective July 1, 2013, the current membership of the State Board of
- 21 <u>Election Commissioners is terminated</u>. The terms of the new members of the
- 22 State Board of Election Commissioners as appointed under this act shall begin
- 23 <u>on July 1, 2013.</u>

- 25 SECTION 3. EMERGENCY CLAUSE. It is found and determined by the
- 26 General Assembly of the State of Arkansas that the composition of the
- 27 membership of the State Board of Election Commissioners is essential to the
- 28 integrity of the election process, that honest and effective elections are
- 29 <u>essential to the preservation of citizens' right to vote, that all elections</u>
- 30 should be conducted by the most qualified and experienced persons in the
- 31 state, and that it is necessary to appoint and orient new members to the
- 32 <u>State Board of Election Commissioners to ensure that they will be prepared</u>
- 33 for the 2013 annual school election. Therefore, an emergency is declared to
- 34 exist, and this act being immediately necessary for the preservation of the
- 35 public peace, health, and safety shall become effective on:
- 36 (1) The date of its approval by the Governor;

1	(2) If the bill is neither approved nor veloed by the Governor,
2	the expiration of the period of time during which the Governor may veto the
3	<pre>bill; or</pre>
4	(3) If the bill is vetoed by the Governor and the veto is
5	overridden, the date the last house overrides the veto.
