3	SECTION 2. Arkansas Code Title 6, Chapter 13, Subchapter 16, is
4	amended to add an additional section to read as follows:
5	6-13-1613. Automatic waiver granted.
6	(a)(1) The Department of Education shall grant an automatic waiver to
7	a school district placed on the consolidation list by the department under \S
8	$\underline{\text{6-13-1602}}$ and notify the school district within thirty (30) days of placing a
9	school district on the consolidation list if the school district is not in
10	violation of Standards of Accreditation for Arkansas Public Schools and
11	School Districts and is not currently classified in academic distress,
12	facilities distress, or fiscal distress.
13	(2)(A) The department shall notify a school district that the
14	school district is not entitled to an automatic waiver within thirty (30)
15	days of placing the school district on the consolidation list if the
16	department determines that the school district is not entitled to an
17	automatic waiver because the school district is classified in academic
18	distress, facilities distress, fiscal distress, or in violation of the
19	Standards of Accreditation for Arkansas Public Schools and School Districts.
20	(B) The notification provided under subdivision (2)(A)
21	shall include the specific reason for the denial of the automatic waiver and
22	$\underline{\text{provide a thirty-day window for the school district to cure the deficiency } \underline{\text{if}}$
23	possible.
24	(3) A school district that is granted an automatic waiver under
25	this section may still voluntarily consolidate under § 6-13-1417.
26	(4) The department shall submit a copy of a notice of approval
27	or denial of an automatic waiver to the State Board of Education.
28	(b)(l) A school district that is placed on the consolidation list by
29	the department under § 6-13-1602 and that is not entitled to an automatic
30	waiver because the school district is classified in academic distress, fiscal
31	distress, facilities distress, or in violation of the Standards of
32	Accreditation for Arkansas Public Schools and School Districts shall be
33	afforded the same assistance and duration of time as provided to other school
34	districts under § 6-15-429 or § 6-20-1908 to remedy any issues that resulted
35	in the school district's being placed in academic distress or fiscal
36	distress.

1	(2) If a school district placed on the consolidation list by the
2	department under § 6-13-1602 that is classified in academic distress or
3	fiscal distress remedies the issue or issues that resulted in the school
4	district's being classified in academic distress or fiscal distress and is
5	$\underline{\text{removed from academic distress or fiscal distress, the school district } shall$
6	be granted an automatic waiver from administrative reorganization under this
7	section.
8	(3) A school district that is classified in academic distress,
9	fiscal distress, facilities distress, or in violation of the Standards of
10	Accreditation for Arkansas Public Schools and School Districts on January 1,
11	2015 is subject to this section.
12	
13	SECTION 3. EMERGENCY CLAUSE. It is found and determined by the
14	General Assembly of the State of Arkansas that small school districts are at
15	risk of being consolidated or reorganized; that small school districts that
16	are successful in educating their students and are not in academic or fiscal
17	distress should not be consolidated or reorganized; and that this act is
18	immediately necessary to ensure that small school districts that are placed
19	on the consolidation list are not consolidated immediately. Therefore, an
20	emergency is declared to exist, and this act being immediately necessary for
21	the preservation of the public peace, health, and safety shall become
22	effective on:
23	(1) The date of its approval by the Governor;
24	(2) If the bill is neither approved nor vetoed by the Governor,
25	the expiration of the period of time during which the Governor may veto the
26	bill; or
27	(3) If the bill is vetoed by the Governor and the veto is
28	overridden, the date the last house overrides the veto.
