8	(a)(1) A law enforcement officer is required to complete a training	
9	program of at least twenty (20) hours in the following areas before being	
10	certified by the Arkansas Commission on Law Enforcement Standards and	
11	Training under this subchapter:	
12	(A) Investigation of and circumstances surrounding cases	
13	involving domestic violence; and	
14	(B) Investigation of and circumstances surrounding cases	
15	involving child abuse.	
16	(2) Practicum training is sufficient for the requirements under	
17	subdivision (a)(l) of this section.	
18	(b) A certified law enforcement officer is required to complete a	
19	supplemental training program or other instructional course annually
