10	of winning designated prizes is the deposit of at least a specified amount of			
11	moneys into a savings account or other savings program offered by the			
12	financial institution.			
13	(b) A financial institution may conduct a savings promotion raffle for			
14	depositors who make a savings promotion deposit into a savings account of the			
15	financial institution.			
16	(c) A savings promotion raffle shall be conducted so that each savings			
17	promotion deposit provides a depositor with an equal chance of winning a			
18	prize as designated by the financial institution.
