- 26 agent license who shall satisfactorily completes complete the examination and
- 27 meets meet the other qualifications and requirements prescribed by law,
- 28 including the completion of a minimum of eight (8) hours of education in
- 29 subjects pertaining to the authority and responsibilities of a bail bondsman
- 30 <u>licensed bail bond agent</u> and a review of the laws and regulations relating
- 31 thereto, shall be licensed by the Professional Bail Bond Company and
- 32 Professional Bail Bondsman Licensing Board rules.
- 33 (b) An applicant for a class 2 bail bond agent license shall satisfy
- 34 the requirements for a class 1 bail bond agent license as well as complete
- 35 one hundred (100) hours of in-classroom instruction and training, including
- 36 <u>without limitation the following topics:</u>

1	<u>(1)</u>	Fourth Amendment search and seizure;
2	<u>(2)</u>	Use of force;
3	<u>(3)</u>	Lawful entry into a residence; and
4	<u>(4)</u>	Firearms qualification.
