23	WHEREAS, because Andrea was a young girl with cerebral palsy, her
24	mother, BJ Thorn, was concerned about the emotional implications of entering
25	her daughter in a beauty pageant; and

27	WHEREAS, Andrea was a determined young girl who persisted in her
28	requests for a pageant; her mother, BJ, began to research and found that
29	there was no local or regional pageant for contestants with special needs;
30	and BJ created the Arkansas Angels Pageant for anyone with special needs,
31	along with the help of Andrea's father and sisters, Johnathan, Bailee Jo, and
32	Lauren Grace Thorn; and

34	WHEREAS, the first pageant was held on March 19, 2011, and over 100
35	children were crowned Arkansas Angels that day; and

2	and though she was unable to participate in the first pageant, the show went
3	on as planned; and

7	needs crowned to date; and

9	WHEREAS, the pageant has grown quickly in popularity and now there are
10	Angels Pageants held all over the United States to give children and adults
