11	(1) Applies for participation in the		
12	program within thirty-one (31) days of returning to active employment; and		
13	(2) Is employed in a position that is		
14	eligible to participate in the program.		
15	(b) If a retiree declines to participate in		
16	the program upon returning to active employment under subdivision		
17	(a)(5)(B)(ii)(a) of this section, the retiree may participate in the program

23	SECTION 2. Arkansas Code $ 21-5-411(a)(2)(C)(ii)(a) $ , concerning the		
24	eligibility of certain retired employees, is amended to read as follows:		
25	(ii)(a) If an active retiree declining to		
26	participate in the program specifies in writing and provides a letter of		
27	creditable employer group coverage to show that the reason for the		
28	declination is that the active retiree had coverage through another employer		
29	group health plan and the active retiree's coverage was subsequently		
30	terminated because of a loss of eligibility, as defined by Internal Revenue		
31	Service regulations, and provides information from the former insurance		
32	company of the loss of eligibility, then the active retiree and any		
33	dependents shall qualify for participation in the program upon payment of the		
34	appropriate premium as <del>established</del> <u>determined</u> by the board <u>under subdivision</u>		
35	(a)(5) of this section if the active retiree applies for participation in the		
36	program within thirty (30) days of the loss of eligibility.

2	SECTION 3. Arkansas Code § 21-5-411(a)(3)(C)(ii), concerning the		
3	eligibility of certain retired employees, is amended to read as follows:		
4	(ii) If an inactive retiree as described in		
5	subdivision (a)(3)(B) of this section declining participation in the program		
6	specifies in writing that the reason for the declination is that the inactive		
7	retiree has coverage through another group health plan and the inactive		
8	retiree's coverage is subsequently terminated because of a loss of		
9	eligibility, then the inactive retiree and any dependents shall qualify for		
10	participation in the program upon payment of the appropriate premium as		
11	established determined by the board under subdivision (a)(5) of this section,		
12	provided the inactive retiree applies for program participation within		
13	thirty-one (31) days of the loss of eligibility.		
14			
15	SECTION 4. Arkansas Code § 21-5-411(a)(3)(D), concerning the		
16	eligibility of certain retired employees, is amended to read as follows:		
17	(D) An eligible inactive retiree shall be reclassified as		
18	an active retiree upon electing to receive a retirement benefit by a		
19	retirement system listed under subdivision (a)(1)(A) of this section and		
20	shall be charged the premium rate appropriate for his or her rating category		
21	as an active retiree <u>as determined</u> by the board under subdivision (a)(5) of		
22	this section.		
23			
24	SECTION 5. Arkansas Code § 21-5-411(b)(1), concerning the eligibility		
25	of certain retired employees, is amended to read as follows:		
26	(b)(1) Retirees who draw retirement benefits under the Arkansas Public		
27	Employees' Retirement System, the Arkansas Teacher Retirement System, or the		
28	Arkansas State Highway Employees' Retirement System and retired contract		
29	employees of the Arkansas National Guard who wish to participate in the		
30	program shall pay the retiree amount of the premium as determined by the		
31	board under subdivision (a)(5) of this section or the cost of the policy
