27 SECTION 1. Arkansas Code § 26-5-104 is repealed.

~~(2) The committee may consider any and all matters relating to recommendations of the commission and the activities of the members in representing this state on it.~~

SECTION 2. Arkansas Code Title 26, Chapter 5, Subchapter 1, is amended to add an additional section to read as follows:

26-5-109. Annual Multistate Tax Commission report.

(a) The Department of Finance and Administration shall prepare an annual report detailing the activities of the Multistate Tax Commission and Arkansas's participation in the activities of the commission.

(b) The report required under this section shall:

(1) Include without limitation the recommendations of the commission and any activity on Arkansas's behalf by representatives of the department; and

(2) Be filed with the President Pro Tempore of the Senate and the Speaker of the House of Representatives no later than September 30 or the next regular business day if September 30 falls on a weekend or legal holiday.
