21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23 SECTION 1. APPROPRIATION - STATE OPERATIONS. There is hereby
24 appropriated, to the Department of Education - Arkansas School for the Blind,
25 to be payable from the School for the Blind Fund Account, for operating
26 expenses and capital outlay of the Department of Education - Arkansas School
27 for the Blind - State Operations which shall be supplemental and in addition
28 to those funds appropriated in Section 3 of Act 53 of 2015, the following:

1 Assembly that any funds disbursed under the authority of the appropriations
2 contained in this act shall be in compliance with the stated reasons for
3 which this act was adopted, as evidenced by the Agency Requests, Executive
4 Recommendations and Legislative Recommendations contained in the budget
5 manuals prepared by the Department of Finance and Administration, letters, or
6 summarized oral testimony in the official minutes of the Arkansas Legislative
7 Council or Joint Budget Committee which relate to its passage and adoption.
8

9 SECTION 6. EMERGENCY CLAUSE. It is found and determined by the General
10 Assembly, that funds provided by the General Assembly for the operations of
11 the Department of Education - Arkansas School for the Blind are, due to
12 unforeseen circumstances, insufficient for the Department of Education -
13 Arkansas School for the Blind to continue to provide essential governmental
14 services; that the provisions of this act will provide the necessary monies
15 for the Department of Education - Arkansas School for the Blind to continue
16 such services; and that a delay in the effective date of this Act could work
17 irreparable harm upon the proper administration and provision of essential
18 governmental programs. Therefore, an emergency is hereby declared to exist
19 and this Act being necessary for the immediate preservation of the public
20 peace, health and safety shall be in full force and effect from and after the
21 date of its passage and approval.

22 If the bill is neither approved nor vetoed by the Governor, it shall
23 become effective on the expiration of the period of time during which the
24 Governor may veto the bill. If the bill is vetoed by the Governor and the
25 veto is overridden, it shall become effective on the date the last house
26 overrides the veto.
