AN ACT TO REAPPROPRIATE THE BALANCES OF CAPITAL
IMPROVEMENT APPROPRIATIONS FOR THE DEPARTMENT OF
HUMAN SERVICES; AND FOR OTHER PURPOSES.

Subtitle

AN ACT FOR THE DEPARTMENT OF HUMAN
SERVICES REAPPROPRIATION.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. REAPPROPRIATION - DIVISION OF AGING AND ADULT SERVICES.

There is hereby appropriated, to the Department of Human Services - Division of Aging and Adult Services, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Department of Human Services - Division of Aging and Adult Services the following:

(A) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 1 of Act 424 of 2015, for grants for construction, renovation, personal services and operating expenses, purchase of equipment, and major maintenance of Senior Citizen Centers, in a sum not to exceed\$10,000.

(B) Effective July 1, 2016, the balance of the appropriation provided in Item (B) Section 1 of Act 424 of 2015, for grants for personal services and operating expenses, construction, renovation, and the purchase of equipment to provide various community-based senior services, including but not limited to, congregate and home-delivered meals, client representation, information and assistance, socialization, adult day care and transportation, in a sum not to exceed.....\$10,000.



(C) Effective July 1, 2016, the balance of the appropriation provided in Item (C) Section 1 of Act 424 of 2015, for grants for hospice providers for construction, renovation, personal services, operating, purchase of equipment, and major maintenance expenses, in a sum not to exceed

.....\$15,000.
(D) Effective July 1, 2016, the balance of the appropriation provided in Item (D) Section 1 of Act 424 of 2015, for a grant to Area Agencies on Aging for construction, renovation, personal services and operating expenses, purchase of equipment, and major maintenance of Senior Citizen Centers, in a sum not to exceed.....\$20,000.

(E) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 1 of Act 437 of 2015, for grants for construction, renovation, personal services and operating expenses, purchase of equipment, and major maintenance of Senior Citizen Centers, in a sum not to exceed

.....\$20,000.
(F) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 1 of Act 636 of 2015, for grants for Meals on Wheels providers for construction, renovation, personal services, operating expenses, purchase of equipment and major maintenance expenses, in a sum not to exceed.....\$10,000.

(G) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 1 of Act 640 of 2015, for grants for construction, renovation, personal services and operating expenses, purchase of equipment, and major maintenance of Senior Citizen Centers, in a sum not to exceed

.....\$20,000.
(H) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 1 of Act 792 of 2015, for grants to Area Agencies on Aging for construction, renovation, personal services and operating expenses, purchase of equipment, and major maintenance of Senior Citizen Centers, in a sum not to exceed.....\$20,000.

SECTION 2. REAPPROPRIATION - DIVISION OF ADMINISTRATIVE SERVICES.

There is hereby appropriated, to the Department of Human Services - Division of Administrative Services, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Department of Human Services - Division of Administrative Services the following:

(A) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 1 of Act 180 of 2015, for various maintenance, renovation, equipping, construction, acquisition, improvement, upgrade and repair of real property and facilities department-wide, in a sum not to exceed.....\$2,300,000.

SECTION 3. REAPPROPRIATION - DIVISION OF BEHAVIORAL HEALTH SERVICES.

There is hereby appropriated, to the Department of Human Services - Division of Behavioral Health Services, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Department of Human Services - Division of Behavioral Health Services the following:

(A) Effective July 1, 2016, the balance of the appropriation provided in Item (E) Section 8 of Act 118 of 2015, for grants for Treatment Programs for personal services and operating expenses, construction, improvements, equipment, renovation and maintenance expenses, in a sum not to exceed\$10,000.

(B) Effective July 1, 2016, the balance of the appropriation provided in Item (J) Section 8 of Act 118 of 2015, for a transfer to the Drug Abuse Prevention and Treatment Fund for behavioral health services to the citizens of the State of Arkansas, in a sum not to exceed.....\$25,000.

(C) Effective July 1, 2016, the balance of the appropriation provided in Item (K) Section 8 of Act 118 of 2015, for a transfer to the Drug Abuse Prevention and Treatment Fund for behavioral health services to the citizens of the State of Arkansas, in a sum not to exceed.....\$90,000.

(D) Effective July 1, 2016, the balance of the appropriation provided in Item (L) Section 8 of Act 118 of 2015, for grants for Alcohol and Substance Abuse Prevention for personal services and operating expenses, construction, improvements, equipment, renovation and maintenance expenses, in a sum not to exceed.....\$25,000.

(E) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 3 of Act 635 of 2015, for a grant to a transitional living shelter for women 18 or older who have been treated for a mental, physical or emotional disability for personal services, operating expenses, construction, improvements, equipment, renovation and maintenance expenses, in a sum not to exceed.....\$10,000.

SECTION 4. REAPPROPRIATION - DIVISION OF COMMUNITY SERVICE AND
NONPROFIT SUPPORT. There is hereby appropriated, to the Department of Human
Services - Division of Community Service and Nonprofit Support, to be payable
from the General Improvement Fund or its successor fund or fund accounts, for
the Department of Human Services - Division of Community Service and
Nonprofit Support the following:

(A) Effective July 1, 2016, the balance of the appropriation provided
in Item (A) Section 4 of Act 118 of 2015, for grants to Community
Organizations which provide services to the poor for construction,
renovation, personal services and operating expenses, purchase of equipment,
and major maintenance, in a sum not to exceed.....\$6,500.

SECTION 5. REAPPROPRIATION - DIVISION OF DEVELOPMENTAL DISABILITIES
SERVICES. There is hereby appropriated, to the Department of Human Services
- Division of Developmental Disabilities Services, to be payable from the
General Improvement Fund or its successor fund or fund accounts, for the
Department of Human Services - Division of Developmental Disabilities
Services the following:

(A) Effective July 1, 2016, the balance of the appropriation provided
in Item (A) Section 1 of Act 183 of 2015, for costs associated with
demolition, construction, replacement, renovation, upgrade and addition of
facilities at the Booneville Human Development Center, in a sum not to exceed
.....\$7,778,144.

(B) Effective July 1, 2016, the balance of the appropriation provided
in Item (A) Section 1 of Act 425 of 2015, for grants to Human Development
Centers serving developmentally disabled individuals for personal services
and operating expenses, construction, improvements, equipment, renovation and
maintenance expenses, in a sum not to exceed.....\$50,000.

(C) Effective July 1, 2016, the balance of the appropriation provided
in Item (A) Section 1 of Act 614 of 2015, for a grant to the Conway Human
Development Center serving developmentally disabled individuals for personal
services and operating expenses, construction, improvements, equipment,
renovation, and maintenance expenses, in a sum not to exceed.....\$25,000.

SECTION 6. REAPPROPRIATION - DEPARTMENT OF HUMAN SERVICES. There is
hereby appropriated, to the Department of Human Services, to be payable from

the General Improvement Fund or its successor fund or fund accounts, for the Department of Human Services the following:

(A) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 10 of Act 118 of 2015, for the Department of Human Services for personal services, operating expenses, and programmatic materials for the Safe Haven Program, in a sum not to exceed.....\$57,996.

(B) Effective July 1, 2016, the balance of the appropriation provided in Item (C) Section 10 of Act 118 of 2015, for various maintenance, renovation, equipping, construction, acquisition, improvement, upgrade and repair of real property and facilities department-wide, in a sum not to exceed.....\$80,000.

(C) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 1 of Act 642 of 2015, for grants for construction, renovation, personal services, operating expenses, purchase of equipment and major maintenance for After School Programs, in a sum not to exceed\$50,000.

(D) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 1 of Act 820 of 2015, for a grant for personal services, operating expenses, construction, renovation and the purchase of equipment to the Hunger Relief Alliance for feeding the needy of the State of Arkansas, in a sum not to exceed.....\$1,000,000.

SECTION 7. REAPPROPRIATION - DIVISION OF MEDICAL SERVICES. There is hereby appropriated, to the Department of Human Services - Division of Medical Services, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Department of Human Services - Division of Medical Services the following:

(A) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 1 of Act 182 of 2015, for grant payments of the Arkansas Medicaid Program of the Department of Human Services - Division of Medical Services - Grants, in a sum not to exceed.....\$90,000,000.

SECTION 8. REAPPROPRIATION - DIVISION OF YOUTH SERVICES. There is hereby appropriated, to the Department of Human Services - Division of Youth Services, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Department of Human Services - Division of

Youth Services the following:

(A) Effective July 1, 2016, the balance of the appropriation provided in Item (B) Section 3 of Act 118 of 2015, for grants to community based programs and juvenile delinquency prevention programs for personal services and operating expenses, construction, improvements, equipment, renovation, and maintenance expenses, in a sum not to exceed.....\$50,000.

(B) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 1 of Act 154 of 2015, for upgrades and improvements to the surveillance systems at all juvenile detention facilities of the Department of Human Services - Division of Youth Services, in a sum not to exceed.....\$5,000,000.

SECTION 9. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor obligations otherwise incurred in relation to the project or projects described herein in excess of the State Treasury funds actually available therefor as provided by law. Provided, however, that institutions and agencies listed herein shall have the authority to accept and use grants and donations including Federal funds, and to use its unobligated cash income or funds, or both available to it, for the purpose of supplementing the State Treasury funds for financing the entire costs of the project or projects enumerated herein. Provided further, that the appropriations and funds otherwise provided by the General Assembly for Maintenance and General Operations of the agency or institutions receiving appropriation herein shall not be used for any of the purposes as appropriated in this act.

(B) The restrictions of any applicable provisions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law and any other applicable fiscal control laws of this State and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of any funds provided by this act unless specifically provided otherwise by law.

SECTION 10. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive

2 manuals prepared by the Department of Finance and Administration, letters, or
3 summarized oral testimony in the official minutes of the Arkansas Legislative
4 Council or Joint Budget Committee which relate to its passage and adoption.

6 SECTION 11. EMERGENCY CLAUSE. It is found and determined by the
7 General Assembly, that the Constitution of the State of Arkansas prohibits
8 the appropriation of funds for more than a one (1) year period; that the
9 effectiveness of this Act on July 1, 2016 is essential to the operation of
10 the agency for which the appropriations in this Act are provided, and that in
11 the event of an extension of the legislative session, the delay in the
12 effective date of this Act beyond July 1, 2016 could work irreparable harm
13 upon the proper administration and provision of essential governmental
14 programs. Therefore, an emergency is hereby declared to exist and this Act
15 being necessary for the immediate preservation of the public peace, health
16 and safety shall be in full force and effect from and after July 1, 2016.
