Determining the maximum number of employees and the maximum amount of appropriation and general revenue funding for a state agency each fiscal year is the prerogative of the General Assembly. This is usually accomplished by delineating such maximums in the appropriation act(s) for a state agency and the general revenue allocations authorized for each fund and fund account by amendment to the Revenue Stabilization law. Further, the General Assembly has determined that the Department of Arkansas State Police may operate more efficiently if some flexibility is provided to the Department of Arkansas State Police authorizing broad powers under this Section. Therefore, it is both necessary and appropriate that the General Assembly maintain oversight by requiring prior approval of the Legislative Council or Joint Budget Committee as provided by this section. The requirement of approval by the Legislative Council or Joint Budget Committee is not a severable part of this section. - 18 is the prerogative of the General Assembly. This is usually accomplished by
- 19 delineating such maximums in the appropriation act(s) for a state agency and
- 20 the general revenue allocations authorized for each fund and fund account by
- 21 amendment to the Revenue Stabilization law. Further, the General Assembly
- 22 has determined that the Department of Arkansas State Police may operate more
- 23 efficiently if some flexibility is provided to the Department of Arkansas
- 24 State Police authorizing broad powers under this Section. Therefore, it is
- 25 both necessary and appropriate that the General Assembly maintain oversight
- 26 by requiring prior approval of the Legislative Council or Joint Budget
- 27 Committee as provided by this section. The requirement of approval by the
- 28 Legislative Council or Joint Budget Committee is not a severable part of this
- 29 section. If the requirement of approval by the Legislative Council or Joint
- 30 Budget Committee is ruled unconstitutional by a court of competent
- 31 jurisdiction, this entire section is void.
- 32 The provisions of this section shall be in effect only from July 1, 2016
- 33 2017 through June 30, 2017 2018.

- 35 SECTION 17. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
- 36 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. MOTOR

- 1 VEHICLE ACQUISITION REVOLVING FUND MOTOR VEHICLE PURCHASES/RENOVATION. At
- 2 least fifty percent (50%) of the general revenues and/or general improvement
- 3 funds deposited into the Motor Vehicle Acquisition Revolving Fund shall be
- 4 used for motor vehicle purchases and/or motor vehicle renovation costs for
- 5 the Department of Arkansas State Police.
- The provisions of this section shall be in effect only from July 1, 2016 7 2017 through June 30, 2017 2018.

- 9 SECTION 18. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
- 10 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. OVERTIME.
- 11 The Department of Arkansas State Police is hereby authorized to make overtime
- 12 payments from such funds and appropriations provided for overtime payments to
- 13 those officers or other employees that are currently assigned or may be
- 14 assigned by the Director of the Department of Arkansas State Police to
- 15 Special Law Enforcement Task Forces and other special programs reimbursable
- 16 to Arkansas State Police by federal or local authorities as approved by the
- 17 Director of the Department of Arkansas State Police. All such overtime
- 18 payments shall be processed through the State Accounting System and shall be
- 19 in addition to the Regular Salaries and benefits accruing to the employee.
- 20 Payment of overtime is the preferred method of implementing the provisions of
- 21 this section.
- The provisions of this section shall be in effect only from July 1, 2016
- 23 <u>2017</u> through June 30, 2017 <u>2018</u>.

- 25 SECTION 19. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
- 26 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. MOTOR
- 27 VEHICLE PURCHASE. The Department of Arkansas State Police is hereby
- 28 authorized to purchase motor vehicles from the appropriations authorized for
- 29 Capital Outlay in the State Police Operations appropriation in this Act.
- 30 Motor vehicles donated to Arkansas State Police and confiscated vehicles used
- 31 for Arkansas State Police operations shall not be included in the maximum
- 32 number of authorized passenger vehicles.
- 33 The provisions of this section shall be in effect only from July 1, 2016
- 34 <u>2017</u> through June 30, 2017 <u>2018</u>.

36 SECTION 20. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

- 1 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. UNIFORM
- 2 EMPLOYEE HEALTH INSURANCE PROGRAM REPORTING. The Department of Arkansas
- 3 State Police shall report monthly to the Governor, the Chief Fiscal Officer
- 4 of the State and to the Arkansas Legislative Council or Joint Budget
- 5 Committee regarding the activity and condition for the uniformed employee
- 6 health insurance plan. The report shall include, but not limited to, the
- 7 beginning reserve fund balance, contributions made during the month, claims
- 8 paid, and the ending fund balance of the month. In the event it is determined
- 9 that the cost to adequately maintain the uniform employee health insurance
- 10 plan is not feasible within the existing resources available to the
- 11 department, the 90^{th} 91^{st} General Assembly shall study the feasibility and
- 12 desirability of discontinuing the self-insurance program and instead provide
- 13 medical and hospital insurance to uniform employees through the public
- 14 employees insurance program.
- The provisions of this section shall be in effect only from July 1, 2016
- 16 2017 through June 30, 2017 2018.

- 18 SECTION 21. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
- 19 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
- 20 EXTRAORDINARY EXPENSES. The Department of Arkansas State Police is hereby
- 21 authorized to purchase from Maintenance & Operations Classifications in the
- 22 Operations Appropriation provided by this Act, up to an amount not to exceed
- 23 two thousand five hundred dollars (\$2,500) each fiscal year, for emergency
- 24 purchases for food, drinks and other essential items during emergency
- 25 operations only when authorized by the Agency Director. During an emergency,
- 26 an ASP employee may be designated and authorized, by the Director, to incur
- 27 expenses for all deployed personnel.
- The provisions of this section shall be in effect only from July 1, $\frac{2016}{1}$
- 29 <u>2017</u> through June 30, 2017 <u>2018</u>.

- 31 SECTION 22. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
- 32 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ARKANSAS
- 33 WIRELESS INFORMATION NETWORK. Once the requirements of Arkansas Code §12-8-
- 34 310 are satisfied, the second two million dollars (\$2,000,000) two million
- 35 <u>five hundred thousand dollars (\$2,500,000)</u> deposited into the Department of
- 36 Arkansas State Police Fund generated by Arkansas Code §27-16-801(a) shall be

1 used for the operations, maintenance, equipment and various system

- 2 requirements and expenses of the Department of Arkansas State Police -
- 3 Arkansas Wireless Information Network.

4 The provisions of this section shall be in effect only from July 1, 2016

5 2017 through June 30, 2017 2018.

7 SECTION 23. COMPLIANCE WITH OTHER LAWS. Disbursement of funds

- 8 authorized by this act shall be limited to the appropriation for such agency
- 9 and funds made available by law for the support of such appropriations; and
- 10 the restrictions of the State Procurement Law, the General Accounting and
- 11 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
- 12 Procedures and Restrictions Act, or their successors, and other fiscal
- 13 control laws of this State, where applicable, and regulations promulgated by
- 14 the Department of Finance and Administration, as authorized by law, shall be
- 15 strictly complied with in disbursement of said funds.

17 SECTION 24. LEGISLATIVE INTENT. It is the intent of the General

- 18 Assembly that any funds disbursed under the authority of the appropriations
- 19 contained in this act shall be in compliance with the stated reasons for
- 20 which this act was adopted, as evidenced by the Agency Requests, Executive
- 21 Recommendations and Legislative Recommendations contained in the budget
- 22 manuals prepared by the Department of Finance and Administration, letters, or
- 23 summarized oral testimony in the official minutes of the Arkansas Legislative
- 24 Council or Joint Budget Committee which relate to its passage and adoption.

- 26 <u>SECTION 25. EMERGENCY CLAUSE.</u> It is found and determined by the
- 27 General Assembly, that the Constitution of the State of Arkansas prohibits
- 28 the appropriation of funds for more than a one (1) year period; that the
- 29 <u>effectiveness of this Act on July 1, 2017 is essential to the operation of</u>
- 30 the agency for which the appropriations in this Act are provided, and that in
- 31 the event of an extension of the legislative session, the delay in the
- 32 effective date of this Act beyond July 1, 2017 could work irreparable harm
- 33 upon the proper administration and provision of essential governmental
- 34 programs. Therefore, an emergency is hereby declared to exist and this Act
- 35 being necessary for the immediate preservation of the public peace, health
- 36 and safety shall be in full force and effect from and after July 1, 2017.
