- 11 SECTION 9. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
- 12 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
- 13 DIRECTOR'S OFFICE/OFFICE OF CHIEF COUNSEL PURCHASE OF EVIDENCE. Upon
- 14 approval by the Chief Fiscal Officer of the State, the Chief Counsel for the
- 15 Department of Human Services may transfer an amount up to but not to exceed
- 16 \$12,000 and deposit same in a bank account for the purpose of purchasing
- 17 evidence in the course of investigating the illegal use of food
- 18 stamps/Electronic Benefit Transfer (EBT) cards. The funds so transferred
- 19 shall be subject to accounting in a manner substantially similar to that

- SECTION 10. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
- 27 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. HUMAN
- 28 SERVICES RENOVATION FUND. Department of Human Services Renovation Fund.
- 29 (a) There is established on the books of the Treasurer of State, Auditor
- 30 of State, and the Chief Fiscal Officer of the State a fund to be known as the
- 31 Department of Human Services Renovation Fund.
- 32 (b) This fund shall be used for constructing, acquiring, renovating,
- 33 maintaining, repairing, and equipping facilities of the Department of Human
- 34 Services and for paying disallowances by the federal government.
- 35 (c) The fund shall consist of:
 - (1) Federal reimbursement received by the Department of Human Services and

- l deposited in the various fund accounts of the department; and

- 4 Disabilities Services for the purposes of repairing, renovating, equipping,

- 7 these transfers are authorized must be projects which were unanticipated
- 8 during the preceding regular session of the Arkansas General Assembly and
- 9 must be projects which, if not carried out in the interim period between

- 11 the facilities, clients or programs of the Department of Human Services than
- 12 to wait until the next regular session.
- 13 (3) Other non-general revenue funds as may be available within the Department

- 15 (d)(1) At the request of the Director of the Department of Human Services,
- 16 and upon certification of the availability of such funds, the Chief Fiscal
- 17 Officer of the State shall initiate the necessary transfer documents to
- 18 reflect the transfer on the books of record of the Treasurer of State, the
- 19 Auditor of State, the Chief Fiscal Officer of the State, and the Department

- 31 (c) YOUTH SERVICES HOUSING AND SEPARATION APPROPRIATION PROVISIONS. The
- 32 Division of Youth Services (DYS) is authorized to fulfill its responsibility
- 33 to house offenders between the ages of 18 and 21 and to separate juvenile
- 34 offenders by age and seriousness of offense by either employing additional
- 35 state employees and providing the corresponding operating expenses or
- 36 entering into professional services contracts. If the Division of Youth

         (d) (c) REALLOCATION OF RESOURCES: (1) The Department of Human Services

     (DHS) provides hundreds of different services to over 1 million Arkansans.

     The specific mix of service needs and the funding and staffing required to

     provide them can vary significantly based on many factors, including natural
11
     disasters, changing federal mandates and funding sources, demographic shifts,
12
     fluctuating court-ordered services, social trends, and job market variations
13
     such as nursing shortages. The impact of these factors through the course of
14
     any fiscal year make it very difficult for the Department to accurately
15
     predict the exact needs for funding, appropriation and positions in each of

     its over 100 different appropriations. To ensure that it can respond quickly

- 34 appropriated in each Division's Act. This program is for eligible nursing
- 35 students who are attending accredited nursing institutions to become
- 36 Registered or Licensed Practical Nurses, as well as Certified Nursing

- 1 Assistants, Residential Care Assistants, Residential Care Technicians,
- 2 Residential Care Supervisors and Behavioral Health Aides.
- 3 The stipend is \$5,000 per person per year. Any student who is awarded and
- 4 accepts a stipend is under employment commitment to the respective DHS
- 5 Division and is required to work for that division, in a full-time employee
- 6 status effective immediately upon graduation. The student employment
- 7 commitment is equal to the number of years the stipend was awarded and
- 8 accepted. In the event of Employee/Student default of the employment
- 9 commitment, the Employee/Student will be considered in breach of contract and
- 10 repayment of the stipend will be required as specified in the Stipend
- 11 Contract.
- 12 Each division participating in the Education Stipend Program shall
- 13 determine on an annual basis, the number of student stipends available.
- 14 The provisions of this section shall be in effect only from July 1, 2016
- 15 <u>2017</u> through June 30, 2017 <u>2018</u>.

- 17 SECTION 13. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
- 18 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
- 19 NURSING/DIRECT CARE RECRUITMENT/RETENTION BONUSES. Special provision to
- 20 provide Nursing/Direct Care Recruitment and Retention Bonuses for the
- 21 Department of Human Services is hereby authorized to be paid from State the
- 22 and Federal funds appropriated for each respective Division. Nursing/direct
- 23 care service recruitment/retention bonuses are in addition to the maximum
- 24 annual amounts provided in the Regular Salaries Section of the respective
- 25 Division's Act for Registered Nurse, Licensed Practical Nurse, Certified
- 26 Nursing Assistant, Residential Care Assistant, Residential Care Technician,
- 27 Residential Care Supervisor and Behavioral Health Aide. New hire nurses must
- 28 be licensed by the Arkansas State Board of Nursing. The total
- 29 recruitment/retention bonus payment commitment for eligible nurses shall not
- 30 exceed \$4,000 per Registered Nurse and \$2,000 per Licensed Practical Nurse
- 31 and \$1,000 per Certified Nursing Assistant, Residential Care Assistant,
- 32 Residential Care Technician, Residential Care Supervisor and Behavioral
- 33 Health Aide.
- 34 The lump sum bonus payments and employment commitment to the State will be
- 35 made in partial payments as follows:

- 1 Registered Nurse Classifications
- 2 \$1,000 after completing 6 months probationary employment
- 3 \$1,500 after completing 1st year employment
- 4 \$1,500 after completing 2nd year employment

- 6 Licensed Practical Nurse Classifications
- 7 \$ 500 after completing 6 months probationary employment
- 8 \$ 500 after completing 1st year employment
- 9 \$1,000 after completing 2nd year employment

- 11 Certified Nursing Assistant/Residential Care Assistant/Residential Care
- 12 Technician/Residential Care Supervisor/Behavioral Health Aide
- 13 Classifications
- 14 \$ 500 after completing 6 months probationary employment
- 15 \$ 500 after completing 1st year employment

- 17 Any qualified person hired and offered bonus payment described herein will
- 18 forfeit the balance of the payments if he/she voluntarily resigns or is
- 19 terminated for cause from employment from the Department of Human Services
- 20 prior to completing the required employment commitment time periods outlined
- 21 above.
- The provisions of this section shall be in effect only from July 1, $\frac{2016}{1}$
- 23 <u>2017</u> through June 30, 2017 <u>2018</u>.

- 25 SECTION 14. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
- 26 authorized by this act shall be limited to the appropriation for such agency
- 27 and funds made available by law for the support of such appropriations; and
- 28 the restrictions of the State Procurement Law, the General Accounting and
- 29 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary

3	Recommendations and Legislative Recommendations contained in the budget

6	Council or Joint Budget Committee which relate to its passage and adoption.

8	SECTION 16. EMERGENCY CLAUSE. It is found and determined by the
9	General Assembly, that the Constitution of the State of Arkansas prohibits
10	the appropriation of funds for more than a one (1) year period; that the
11	effectiveness of this Act on July 1, 2017 is essential to the operation of
12	the agency for which the appropriations in this Act are provided, and that in
13	the event of an extension of the legislative session, the delay in the
14	effective date of this Act beyond July 1, 2017 could work irreparable harm
15	upon the proper administration and provision of essential governmental
16	programs. Therefore, an emergency is hereby declared to exist and this Act
17	being necessary for the immediate preservation of the public peace, health
18	and safety shall be in full force and effect from and after July 1, 2017.
