19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
20

21 *SECTION 1. Arkansas Code Title 7, Chapter 5, Subchapter 9, is amended*
22 *to add an additional subchapter to read as follows:*

23 *Subchapter 9 – Voting and Elections Transparency Act of 2017*
24

25 *7-5-901. Title.*

26 *This subchapter shall be known and cited as the "Voting and Elections*
27 *Transparency Act of 2017".*
28

29 *7-5-902. Uncounted votes.*

30 *(a) If for any reason a vote, including an absentee vote and a*
31 *provisional vote, is not counted under this chapter, the county board of*
32 *election commissioners shall promptly notify the person who cast the vote.*

33 *(b) Notification under subsection (a) of this section shall be written*
34 *notification and shall state the reason or reasons the vote was not counted.*

36 *7-5-903. Voter notification.*



1 (a) The county clerk shall send written notification to a person when:

2 (1) A person registers to vote for the first time;

3 (2) The voter registration of a person becomes inactive; and

4 (3) A person is removed or purged from a voter registration
5 list.

6 (b) If a person is removed or purged from a voter registration list
7 under subdivision (a)(3) of this section, he or she has thirty (30) days to
8 challenge the removal.

9
10 7-5-904. Election commissioners.

11 (a) A member of the State Board of Election Commissioners or a county
12 board of election commissioners shall not serve as a poll worker or a poll
13 watcher on behalf of an individual candidate, political party, or ballot
14 initiative.

15 (b) A person shall not simultaneously serve on the State Board of
16 Election Commissioners and a county board of election commissioners.

17
18 7-5-905. Documentation for long-term care or residential care facility
19 residents.

20 (a) The documentation required to be submitted by a person who is a
21 resident of a long-term care facility or residential care facility licensed
22 by the state under this chapter shall be standardized.

23 (b) The Secretary of State's office shall develop, adopt, and make
24 available a standardized form to satisfy the requirements under law
25 concerning the documentation under subsection (a) of this section.
