16	AN AMENDMENT TO THE ARKANSAS CONSTITUTION
17	TO PROVIDE FOR THE APPOINTMENT OF
18	EMERGENCY INTERIM SUCCESSORS TO CERTAIN
19	CONSTITUTIONAL OFFICES UPON THE
20	OCCURRENCE OF A CATASTROPHIC EVENT.

23	BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIRST GENERAL
24	ASSEMBLY OF THE STATE OF ARKANSAS AND BY THE SENATE, A MAJORITY OF ALL
25	MEMBERS ELECTED TO EACH HOUSE AGREEING THERETO:
26	
27	That the following is proposed as an amendment to the Constitution of
28	the State of Arkansas, and upon being submitted to the electors of the state
29	for approval or rejection at the next general election for Representatives
30	and Senators, if a majority of the electors voting thereon at the election
31	adopt the amendment, the amendment shall become a part of the Constitution of
32	the State of Arkansas, to wit:

34	SECTION 1. Arkansas Constitution, Amendment 29, is amended to add an
35	additional section to read as follows:
36	§ 6. Emergency interim successors due to occurrence of catastrophic

1	event.
2	(a) The General Assembly shall enact laws providing for the
3	$\underline{\text{establishment of emergency interim successors for vacant offices established}}$
4	under this Constitution if a catastrophic event:
5	(1) Results in no person being eligible to assume the office of
6	Governor or act as Governor under this Constitution; or
7	(2) Reduces or incapacitates the total number of persons elected
8	or appointed to the following governmental bodies in a manner that prevents
9	the governmental body from achieving a quorum to conduct the business of the
10	<pre>governmental body:</pre>
11	(A) The General Assembly;
12	(B) The Supreme Court; and
13	(C) Quorum courts.
14	(b) An emergency interim successor under this section shall serve only
15	until:
16	(1) A successor is appointed or elected and qualified under this
17	Constitution; or
18	(2) A lawful incumbent is able to resume the exercise of the
19	powers and discharge the duties of the office.
20	
21	SECTION 2. BALLOT TITLE AND POPULAR NAME. When this proposed
22	amendment is submitted to the electors of this state on the general election
23	<pre>ballot:</pre>
24	(1) The title of this joint resolution shall be the ballot
25	title; and
26	(2) The popular name shall be "A Proposed Amendment to the
27	Arkansas Constitution to Provide for the Appointment of Emergency Interim
28	Successors to Certain Constitutional Offices Upon the Occurrence of a
29	Catastrophic Event."
