10	association receives from a public school district; and		
11	(2) Approval by the Legislative Council of any rules,		
12	regulations, or policies or amendments to rules, regulations, or policies of		
13	the extracurricular activity organization that affect public school students		
14	in this state and the public school districts in which they are enrolled.		
15	(c) A public school district shall not disburse to an extracurricular		
16	activity organization domiciled in the State of Arkansas any funds from the
