20	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22	SECTION 1. Arkansas Code § 14-234-703(b)(1), concerning cooperation
23	between sewer and water utilities, is amended to read as follows:
24	(b)(l) A corresponding water utility shall terminate water service to
25	a customer of the sewer utility who is also a customer of the corresponding
26	water utility upon receiving a signed statement from a representative of the
27	sewer utility that states the following:
28	(A) The <u>That the</u> customer has not paid for sewer utility
29	service for more than fifteen (15) days past the <i>earliest</i> due date shown on
30	the face of the sewer utility bill; and
31	(B) The sewer utility has sent notice to the customer via
32	the United States Postal Service to an address provided by the customer that
33	service will be terminated in no less than fifteen (15) days from the date of
34	mailing if the balance due for sewer utility service and any applicable late
35	fees are not paid; and That the sewer utility has sent notice to the customer
36	by the sewer utility's preferred delivery method of notification from the
