13 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
14
15

16 *SECTION 1. Arkansas Code § 17-20-101 is amended to read as follows:*

17 ~~*Sections 17-20-101—17-20-104, 17-20-201—17-20-209, and 17-20-301—*~~
18 ~~*17-20-310*~~ *This chapter shall be known and may be cited as the “Arkansas*
19 *Barber Law”.*

23 *SECTION 2. Arkansas Code § 17-20-102(a), concerning definitions*
24 *pertaining to barber laws, is amended to read as follows:*

25 *(a) As used in this chapter, unless the context otherwise requires,*
26 *“barbering” means any one (1) or any combination of the following practices*
27 *when performed ~~upon the head, face, and neck~~ for cosmetic purposes and done*
28 *for the public generally for pay, either directly or indirectly in any*
29 *location defined as a barber shop:*

30 *(1) Shaving or trimming the beard;*

31 *(2) Cutting hair;*

32 *(3) Giving facial and scalp massage or application of oils,*
33 *creams, lotions, or other preparations, either by hand or mechanical*
34 *appliances;*

35 *(4) Singeing, shampooing, or applying chemicals;*

36 *(5) Applying cosmetic preparations, antiseptics, powders, oils,*



1 clays, or lotions to scalp, face, or neck; and

2 (6) Use of the traditional symbol known as the "barber pole",
3 which is composed of a vertical cylinder or pole with a ball on top, with
4 alternating stripes of any combination including red and white, and red,
5 white, and blue, which run diagonally along the length of the cylinder or
6 pole, or any likeness thereof, with the intent to mislead the public in any
7 manner that would make the public believe that barbering was being practiced
8 in or that a licensed barber was employed in an establishment that does not
9 employ barbers is prohibited.

10
11 SECTION 3. Arkansas Code § 17-20-103 is amended to read as follows:
12 17-20-103. Exemptions – Construction.

13 (a) The following persons, firms, or corporations are exempt from the
14 provisions of ~~§§ 17-20-101—17-20-104, 17-20-201—17-20-209, and 17-20-301~~
15 ~~—17-20-310~~ under the Arkansas Barber Law, § 17-20-101 et seq., while in the
16 proper discharge of their professional duties:

17 (1) Persons licensed by the laws of this state to practice the
18 healing arts;

19 (2) Commissioned medical or surgical officers of the United
20 States Army, United States Navy, or Marine Hospital Service or United States
21 ~~Public Health Service Commissioned Corps~~ United States Commissioned Corps of
22 the Public Health Service;

23 (3) Persons licensed or registered by the Arkansas State Board
24 of Nursing; ~~and~~

25 (4) Undertakers and morticians; ~~and~~

26 (5) Jails, prisons, or penitentiaries.

27 (b) Nothing contained in ~~§§ 17-20-101—17-20-104, 17-20-201—17-20-~~
28 ~~209, and 17-20-301—17-20-310~~ the Arkansas Barber Law, § 17-20-101 et seq.,
29 shall be construed so as to conflict in any manner with the laws regulating
30 the vocation of cosmetic therapy or beauty culture.

31
32 SECTION 4. Arkansas Code § 17-20-104(c), concerning penalties, is
33 amended to read as follows:

34 (c) The willful making of any false statement to a material matter in
35 any oath or affidavit which is required ~~by the provisions of §§ 17-20-101—~~
36 ~~17-20-104, 17-20-201—17-20-209, and 17-20-301—17-20-310~~ under Arkansas

1 Barber Law shall be perjury and punishable as such.

2
3 SECTION 5. Arkansas Code § 17-20-201(a)(5), concerning the creation of
4 the State Board of Barber Examiners is repealed.

5 ~~(5) The membership of the Secretary of the State Board of Health~~
6 ~~on the State Board of Barber Examiners shall in no way be affected by the~~
7 ~~provisions of § 25-19-211 [Repealed].~~

8
9 SECTION 6. Arkansas Code § 17-20-203(d), concerning the executive
10 secretary of the State Board of Barber Examiners, is repealed.

11 ~~(d) Before entering upon the discharge of the duties of his or her~~
12 ~~office, the executive secretary shall give a bond to the state, to be~~
13 ~~approved by the Governor and filed with the Auditor of State, in the sum of~~
14 ~~five thousand dollars (\$5,000), conditioned for the faithful performance of~~
15 ~~the duties of his or her office.~~

16
17 SECTION 7. Arkansas Code § 17-20-204 is amended to read as follows:
18 17-20-204. Personnel.

19 The State Board of Barber Examiners is authorized to employ such other
20 personnel as it deems necessary to carry out the provisions of ~~§§ 17-20-101—~~
21 ~~17-20-104, 17-20-201—17-20-209, and 17-20-301—17-20-310~~ the Arkansas
22 Barber Law, § 17-20-101 et seq., within such limits as may be provided by
23 biennial appropriation of the General Assembly. All employees shall work
24 under the direct supervision of the ~~board~~ Executive Secretary of the State
25 Board of Barber Examiners.

26
27 SECTION 8. Arkansas Code § 17-20-205 is amended to read as follows:
28 17-20-205. Meetings.

29 The State Board of Barber Examiners shall hold a meeting ~~in Little Rock~~
30 ~~once every month, or at such other places where,~~ at least quarterly at a
31 place where, in the discretion of the board, there are a sufficient number of
32 applicants to warrant holding an examination outside of Little Rock for the
33 purpose of:

- 34 (1) Passing upon barbers' applications;
35 (2) Conducting an examination to determine an applicant's
36 ability to receive a license and shall issue or refuse to issue a license

1 *thereon; and*

2 *(3) Transacting any other business which may properly come*
3 *before it.*

4
5 *SECTION 9. Arkansas Code § 17-20-206 is amended to read as follows:*

6 *17-20-206. Rules and regulations – Inspections.*

7 *(a) The State Board of Barber Examiners shall have authority to make*
8 *and promulgate reasonable rules ~~and regulations~~ for the administration of ~~the~~*
9 *~~provisions of §§ 17-20-101—17-20-104, 17-20-201—17-20-209, and 17-20-301~~*
10 *~~—17-20-310 and for the purpose of carrying out the intent of these~~*
11 *~~subchapters~~ the Arkansas Barber Law, § 17-20-101 et seq.*

12 *(b) It shall prescribe sanitary requirements for barbershops and*
13 *barber schools, subject to the approval of the State Board of Health.*

14 *(c) Any member of the ~~board~~ State Board of Barber Examiners or its*
15 *inspectors shall have authority to enter upon and to inspect any barbershop*
16 *or barber school at any time during business hours.*

17 *(d) A copy of the rules ~~and regulations~~ and sanitary requirements*
18 *adopted by the ~~board~~ State Board of Barber Examiners shall be furnished by*
19 *the board to the owner or manager of each barbershop and barber school, and a*
20 *copy shall be posted in a conspicuous place in the barbershop or barber*

23 *~~promulgation of rules and regulations, subject to the approval of the~~*
24 *~~Attorney General.~~*

26 *SECTION 10. Arkansas Code § 17-20-208 is amended to read as follows:*

27 *17-20-208. Fees.*

28 *(a) The State Board of Barber Examiners shall by ~~regulation~~ rule*
29 *establish reasonable registration fees, renewal fees, examination fees, and*
30 *such other fees as it deems necessary and appropriate to fulfill its duties.*

31 *~~(b) A duplicate certificate will be issued upon the filing of a~~*
32 *~~statement covering the loss of the original certificate, certified by the~~*
33 *~~oath of the applicant, and by submitting one (1) signed photograph, and the~~*
34 *~~payment of a fee of five dollars (\$5.00) for the issuance of the duplicate~~*
35 *~~certificate. Each duplicate certificate shall have the word “Duplicate”~~*
36 *~~stamped across the face thereof and will bear the same number as the original~~*

8 (4) Retainer fees for attorneys;

9 (5) Publication of the Arkansas Barber Law, § 17-20-101 et seq.

11 (6) Investigation of violations of the Arkansas Barber Law, § 17-

16 SECTION 11. Arkansas Code § 17-20-209 is amended to read as follows:
17 17-20-209. Disposition of funds.

18 (a)(1) All moneys received by the State Board of Barber Examiners
19 under ~~§§ 17-20-101—17-20-104, 17-20-201—17-20-209, and 17-20-301—17-20-~~
20 ~~310~~ the Arkansas Barber Law, § 17-20-101 et seq., shall be paid to the
21 Executive Secretary of the State Board of Barber Examiners, who shall give a
22 proper receipt for those moneys. ~~At the end of each month, he or she shall~~
23 ~~report~~ to the Auditor of State the total amount received by him or her ~~under~~
24 ~~the provisions of §§ 17-20-101—17-20-104, 17-20-201—17-20-209, and 17-20-~~
25 ~~301—17-20-310~~ from all sources under the Arkansas Barber Law, § 17-20-101
26 et seq.

27 (2) The executive secretary shall at the same time deposit the
28 entire amount of such receipts with the Treasurer of State, who shall place

31 (b)(1) By its chair and executive secretary, the board shall from time
32 to time certify to the Auditor of State the necessary expenses incurred by
33 the board, including expense reimbursement and stipends as provided in § 25-
34 16-901 et seq. The Auditor of State shall issue his or her warrant for the
35 expenses, which shall be paid out of the funds so established for the
36 maintenance of the board.

 16 SECTION 12. Arkansas Code § 17-20-301 is amended to read as follows:
 17 17-20-301. Certificate required.

18 (a) It shall be unlawful:

19 (1) ~~To practice barbering in this state without a certificate of~~
 20 ~~registration as a registered barber issued pursuant to the provisions of §§~~
 21 ~~17-20-101—17-20-104, 17-20-201—17-20-209, and 17-20-301—17-20-310 by~~
 22 ~~the State Board of Barber Examiners as established in § 17-20-201 et seq. For~~
 23 any person, firm, or corporation to conduct or operate a barber
 24 establishment, school of barbering, barber shop, or any other place of
 25 business in which any occupation of a barber are taught or practiced until
 26 licensed under this chapter and in compliance with this chapter relating to
 27 sanitation;

28 (2) To act or attempt to act as a barber without a certificate
 29 of registration as a registered barber duly issued by the ~~board~~ State Board
 30 of Barber Examiners; and

31 (3) For any person, firm, or corporation to operate a barbershop
 32 unless it is ~~at all times~~ operated under the personal supervision and
 33 management of a registered barber.

34 (b) A person having charge of a barber establishment or school of
 35 barbering, whether as an owner or an employee, shall not permit any room or
 36 part of a room in which any of the branches or practices of barbering are

1 conducted, practiced, or taught to be used for sleeping, for residential
 2 purposes, or for any other purpose that would tend to make the room
 3 unsanitary.

4 (c) A barbering establishment shall have a direct entrance separate
 5 and distinct from any entrance in connection with private quarters.

6 (d)(1) It shall be unlawful for a person to employ or to allow to be
 7 employed, a person not licensed by the board in or about a barber
 8 establishment as a barber manager.

9 (2) If at any time the name, location, owner or manager changes
 10 at any barber shop or barber school or college, the owner shall report that
 11 change by application and be subject to the fee established.

12 (3) If a barbering establishment no longer employs a barber, or
 13 if a barbering establishment is closed, a new application shall be filed with
 14 the board.

15 ~~(b)~~(e) It shall be the responsibility of all barbershop owners to
 16 assure that their employees or those who work in the establishment have
 17 appropriate licenses.

18 (f) Barber establishments who have persons licensed by the Cosmetology
 19 Technical Advisory Committee shall also have their appropriate current
 20 licenses to practice.

21
 22 SECTION 13. Arkansas Code § 17-20-302 is amended to read as follows:
 23 17-20-302. Qualifications of applicants.

24 Any person shall be qualified to receive a certificate of registration
 25 to practice as a registered barber who:

26 (1) ~~Is qualified under the provisions of §§ 17-20-101—17-20-~~
 27 ~~104, 17-20-201—17-20-209, and 17-20-301—17-20-310~~ the Arkansas Barber
 28 Law, § 17-20-101 et seq.;

29 (2) Is of good moral character and temperate habits;

30 (3) Has passed a satisfactory examination conducted by the State
 31 Board of Barber Examiners to determine his or her fitness to practice
 32 barbering and furnishes a diploma showing graduation from a grammar school or
 33 its equivalent as determined by an examination conducted by the board;

34 (4) Is at least sixteen and one-half (16 ½) years of age; and

35 (5) Has received training approved by the appropriate licensing
 36 authorities.

SECTION 14. Arkansas Code § 17-20-303 is amended to read as follows:
17-20-303. Application.

(a) Any person, firm, or corporation desiring to operate as a barber, barber student, teacher manager instructor, teacher manager instructor (TMI) student, barbershop, barber corporation, or barber school or college shall file an application for a certificate of registration on a form furnished by the State Board of Barber Examiners and pay the application fee.

(b) Any person who desires to practice barbering in this state shall file with the Executive Secretary of the State Board of Barber Examiners a written application, ~~under oath~~ duly notarized, with certification of at least one thousand five hundred (1,500) hours of barber training, together with:

(1) ~~two~~ Two (2) identical ~~two-inch by three-inch signed photographs and satisfactory proof that the applicant is of good moral character~~ passport size signed photographs;

(2) A copy of his or her record of identification;

(3) His or her Social Security number; and

(4) Proof of education of at least the eighth grade for a barber applicant or high school graduate for a teacher manager instructor (TMI).

~~(c) Any person recently coming into this state~~ A barber applying for reciprocity who has an unrevoked or unexpired license issued by the proper authorities of another state certifying that he or she has completed a minimum of one thousand five hundred (1500) hours of training, may be issued a certificate of registration as a registered barber upon making the application as required by ~~law~~ the Arkansas Barber Law, § 17-20-101 et seq., and upon the payment of a ~~one hundred fifty dollar~~ reciprocity fee, ~~subject to the conditions outlined in subsection (d) of this section. The reciprocity fee shall~~ that shall include the license fee until the beginning of the next renewal period.

~~(d)(1) Any~~ An unlicensed person applying for reciprocity who has at least one thousand five hundred (1,500) hours of barber training may be granted registration by ~~reciprocity upon completion of those hours and examination upon proof of licensure~~ training by the ~~proper authorities~~ state board in the state in which the person received the training and upon making application as required by law and upon payment of a reciprocity examination

1 fee to obtain registration in this state as a registered barber..

2 (2) ~~Any person~~ A barber applying for reciprocity who has fewer
3 than one thousand five hundred (1,500) hours of barber training must also
4 have been continuously engaged in the practice of barbering for at least one
5 (1) year in addition to providing proof of licensure and training ~~in~~ by the
6 state board where the applicant received training or holds a license, or
7 complete the required number of one thousand five hundred (1500) hours and
8 upon making application as required by law and upon payment of a reciprocity
9 fee to obtain registration in this state as a registered barber..

10 (e)(1) A person applying for reciprocity who is licensed in a foreign
11 country as a barber is required to pass an examination administered by the
12 State Board of Barber Examiners to qualify for a license in this state.

13 (2) All documents submitted for the purpose of complying with
14 the requirements for examination shall be original copies and translated in
15 the English language.

16 (3) The application shall be accompanied with a money order for
17 the reciprocity and examination fee.

18 (f) A person who has been continuously licensed or registered in
19 another state to practice barbering as a teacher manager instructor (TMI) who
20 also meets the requirements under § 17-20-406, may be issued a certificate of
21 registration as a registered barber and teacher manager instructor (TMI) upon
22 making application as required by law and upon payment of a reciprocity fee
23 to obtain registration in this state as a registered barber, plus a teacher
24 manager instructor (TMI) reciprocity fee.

25
26 SECTION 15. Arkansas Code § 17-20-304(c), concerning examinations, is
27 amended to read as follows:

28 (c) ~~Any~~ A person enrolled as a student in ~~any~~ a barber school in this
29 state shall be given credit for all time spent ~~therein~~ enrolled in the barber
30 school, provided that his or her hours can be certified by the officials of
31 the barber school the person attended.

32
33 SECTION 16. Arkansas Code § 17-20-307 is amended to read as follows:
34 17-20-307. Renewal – Expiration – Restoration.

35 (a) Every registered barber or teacher manager instructor (TMI) who
36 continues in active practice or service shall annually between July 1 and ~~on~~

1 ~~or before~~ September 1 renew his or her certificate of registration or shop
2 certificate of registration by paying the required fee.

3 (b) Every certificate of registration which has not been renewed, as
4 herein required, in any year shall expire on September 1 in that year.

5 (c)(1) A registered barber or teacher manager instructor (TMI) whose
6 certificate of registration has ~~been expired for sixty (60) days or less~~ may
7 have his or her certificate or shop certificate of registration restored
8 immediately upon payment of the required restoration fee.

9 (2)(A) Any registered barber or teacher manager instructor (TMI)
10 ~~who retires from the practice of barbering and fails to keep his or her~~
11 registration certificate renewed for not more than three (3) years may renew
12 his or her certificate of registration upon payment of the required
13 restoration fee for each year of delinquency.

14 (B) If the time elapsed is more than three (3) years, he
15 or she must take and pass the required examination and pay the examination
16 fee as set forth by the ~~board~~ State Board of Barber Examiners.

17 (d)(1) A barber who holds a current license in this state shall be
18 issued a personal lifetime license at eighty (80) years of age upon his or
19 her request.

20 (2) However the shop license of a barber under subdivision
21 (d)(1) of this section shall be renewed yearly.

22
23 SECTION 17. Arkansas Code § 17-20-308(1), concerning grounds for
24 disciplinary action, is amended to read as follows:

25 (1)(A) Conviction of a felony shown by a certified copy of the
26 record of the court of conviction;

27 (B) In accordance with § 5-14-129, the board shall refuse
28 to issue or renew a certificate of registration or shall suspend or revoke a
29 certificate of registration for a barber who is a registered sex offender.

30 (C) It is unlawful for a sex offender who is required to
31 register under the Sex Offender Registration Act of 1997, § 12-12-901 et
32 seq., and who has been assessed as a Level 3 or Level 4 offender to knowingly
33 engage in an occupation or participate in a volunteer position that requires
34 the sex offender to work or interact primarily and directly with a child
35 under sixteen (16) years of age.

36 (D) A violation of this section is a Class D felony.

2 SECTION 18. Arkansas Code § 17-20-310(a), concerning civil penalties,
3 is amended to read as follows:

4 (a) Whenever the State Board of Barber Examiners, after a hearing
5 conducted in accordance with the Arkansas Administrative Procedure Act, § 25-
6 15-201 et seq., determines that any person has violated any provision of the
7 Arkansas Barber Law, § 17-20-101 et seq., ~~§§ 17-20-101—17-20-104, 17-20-201~~
8 ~~—17-20-209, and 17-20-301—17-20-310~~ or any regulation rule promulgated by
9 the board ~~pursuant to it~~ under the Arkansas Barber Law, § 17-20-101 et seq.,
10 the board may impose a civil penalty on the person not to exceed two hundred
11 fifty dollars (\$250).

12
13 SECTION 19. The title of Arkansas Code Title 17, Chapter 20,
14 Subchapter 4 is amended to read as follows:

18 SECTION 20. Arkansas Code § 17-20-401 is amended to read as follows:
19 17-20-401. ~~Definition~~ Definitions.

20 As used in this subchapter, unless the context otherwise requires, i:

21 (1) ~~"college"~~ "College" includes school of barbering, college of
22 barbering, barber school, barber college, and any other place or institution
23 of instruction training persons to engage in the practice of barbering, i

24 (2) "Postsecondary school of barbering" means a school or
25 college that admits students who have a high school diploma or the equivalent
26 of a high school diploma who are beyond the age of compulsory school
27 attendance in this state; and

28 (3)(A) "Secondary school of barbering" means a school that
29 admits students who have completed grade eight (8) or the equivalent of grade
30 eight (8) and are at least sixteen and a half (16 ½) years of age; or

31 (B) A school with enrollment made up of no more than fifty
32 percent (50%) of students with neither a high school diploma or equivalent of
33 a high school diploma.

34
35 SECTION 21. Arkansas Code § 17-20-402 is amended to read as follows:
36 17-20-402. Enforcement — Authority of the State Board of Barber

1 Examiners.

2 (a) The State Board of Barber Examiners may commence and maintain all
3 proper and necessary proceedings in order to enforce compliance with any
4 provisions of the laws, or rules, or regulations pertaining to the practice
5 of barbering and, in addition to other remedies, may enforce compliance by
6 injunction.

7 (b) Schools of barbering shall be conducted as provided under this
8 subchapter.

9 (c) A person, firm, or corporation desiring to conduct a school of
10 barbering shall apply to the board for approval and will be inspected and
11 approved before opening to the public.

12 (d) The license issued by the board authorizes a school of barbering
13 to transact operations in this state during the year for which the license is
14 issued, subject to the rules of the board.

15 (e) This section shall not be construed as authorization or permission
16 to conduct a school of barbering without a valid license or with an unexpired
17 license.

18 (f) A license issued by the board shall designate on the written
19 license whether the school of barbering is licensed as:

20 (1) A secondary school of barbering; or

21 (2) A postsecondary school of barbering.

22

23 *SECTION 22. Arkansas Code § 17-20-404 is amended to read as follows:*
24 *17-20-404. Application for registration – Contents.*

25 (a) An application for a license and approval as a registered school
26 or college of barbering shall contain, under oath of the applicant or proper
27 officer of a corporation or association, the following:

28 (1) The full name of the applicant, person, association, or
29 corporation;

30 (2) The exact location where the school or college is located or
31 proposed to be located;

32 (3) Whether or not the school or college is owned or leased and,
33 if leased, the name and residence of the owner or, if a corporation, the
34 directors and stockholders thereof;

35 (4) A detailed drawing of the premises where the instruction is
36 to take place, including the:

- 1 (A) Size of the building;
 2 (B) Number of chairs available;
 3 (C) Sanitary facilities;
 4 (D) Name, number, and qualifications of the teachers on
 5 the staff; and
 6 (E) Proposed number of students;
 7 (5) A statement, certified to by a public accountant licensed to
 8 practice in this state, of the assets and liabilities of the person or firm
 9 making the application;
