18	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20	SECTION 1. Arkansas Code Title 22, Chapter 3, is amended to add an	
21	additional subchapter to read as follows:	
22	Subchapter 21 - Arkansas Heritage Protection Act	
23		
24	22-3-2101. Title.	
25	This subchapter shall be known and may be cited as the "Arkansas	
26	Heritage Protection Act".	
27		
28	<u>22-3-2102.</u> Definitions.	
29	As used in this subchapter:	
30	(1) "Monument" means a statue, memorial, gravestone plate,	
31	nameplate, plaque, historic flag display, school, street, bridge, building,	-
32	preserve, or reserve that:	
33	(A) Is located on public property; and	
34	(B) Has been erected for, or named or dedicated in honor	-
35	of a historical person, historical event, military organization, military	
36	unit, a war, or other military conflict, including without limitation:

1	(i) The French and Indian War;
2	(ii) The American Revolution;
3	(iii) The War of 1812;
4	(iv) The Mexican-American War;
5	(v) The American Civil War;
6	(vi) The Spanish American War;

9	(ix) World War II;
10	(x) The Korean conflict;
11	(xi) The Vietnam War;
12	(xii) Operation Urgent Fury;
13	(xiii) Operation El Dorado Canyon;
14	(xiv) Operation Just Cause;
15	(xv) Operation Desert Shield and Operation Desert
16	Storm;
17	(xvi) Operation Enduring Freedom; and

19	(2) "Person" means an individual or entity; and
20	(3) "Public property" means all property owned or leased by the
21	state, a county, a municipality, or any other entity that is created by an
22	act of the General Assembly to perform a public function.
23	
24	22-3-2103. Preservation of monuments.
25	(a)(1) A monument shall not be relocated, removed, altered, renamed,
26	rededicated, vandalized, damaged, destroyed, or otherwise disturbed.
27	(2) Subdivision (a)(1) of this section does not prohibit a
28	governmental entity having responsibility for maintaining a monument from
29	$\underline{\text{taking proper and appropriate measures, and exercising proper and appropriate}}$
30	means, for the protection, preservation, care, repair, or restoration of the
31	monument.
32	(b)(1) An entity exercising control of public property that is itself
33	a monument or on which a monument is situated may petition the Arkansas
34	History Commission for a waiver of subdivision (a)(1) of this section.
35	(2) A petition for a waiver authorized by subdivision (b)(1) of
36	this section shall:

1	(A) Be in writing; and
2	(B) State the reason the waiver is necessary.
3	(3) The commission may:
4	(A) Grant a petition for a waiver by a majority vote of
5	those present and voting at a regularly scheduled commission meeting; and
6	(B) Unless the monument is a park, street, preserve, or
7	reserve, include reasonable conditions and instructions to ensure that the
8	monument is preserved to the greatest extent possible.
9	
10	22-3-2104. Applicability.
11	(a) This subchapter does not apply to:
12	(1) A temporary exhibit; or
13	(2) Public property under the control of, or acquired by the
14	State Highway Commission when the application of this subchapter would
15	interfere with the construction, maintenance, or operation of the public
16	transportations system.
17	(b) A petition for a waiver may be authorized under § 22-3-2103(b) if
18	the application of this subchapter interferes with the construction,
19	maintenance, or operation of a public facility owned or managed by the
20	Department of Parks and Tourism or the Department of Arkansas Heritage.
21	(C) The Department of Arkansas Heritage.

23	<u>22-3-2105. Penalty.</u>
24	A person who knowingly violates this subchapter is upon conviction
25	guilty of a Class D Felony.
