SECTION 18. LEGISLATIVE INTENT. It is the intent of the General

1	Assembly that any funds disbursed under the authority of the appropriations
2	contained in this act shall be in compliance with the stated reasons for
3	which this act was adopted, as evidenced by the Agency Requests, Executive
4	Recommendations and Legislative Recommendations contained in the budget
5	manuals prepared by the Department of Finance and Administration, letters, or
6	summarized oral testimony in the official minutes of the Arkansas Legislative
7	Council or Joint Budget Committee which relate to its passage and adoption.
8	
9	SECTION 19. EMERGENCY CLAUSE. It is found and determined by the
10	General Assembly, that the Constitution of the State of Arkansas prohibits
11	the appropriation of funds for more than a one (1) year period; that the
12	effectiveness of this Act on July 1, 2019 is essential to the operation of
13	the agency for which the appropriations in this Act are provided; with the
14	exception that Section 13 in this Act shall be in full force and effect from
15	and after the date of its passage and approval, and that in the event of an
16	extension of the Legislative Session, the delay in the effective date of this
17	Act beyond July 1, 2019, with the exception that Section 13 in this Act shall
18	be in full force and effect from and after the date of its passage and
19	approval, could work irreparable harm upon the proper administration and
20	provision of essential governmental programs. Therefore, an emergency is
21	hereby declared to exist and this Act being necessary for the immediate
22	preservation of the public peace, health and safety shall be in full force
23	and effect from and after July 1, 2019; with the exception that Section 13 in
24	this Act shall be in full force and effect from and after the date of its
25	passage and approval.
